# What is this product?

#### Type

This product is a UCITS sub-fund of a variable capital umbrella investment company with segregated liability between sub-funds authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended.

Subject to the conditions set down in the prospectus, shareholders may exchange all or part of their shares of this fund for shares of another fund of the company. Please refer to the section entitled "How To Exchange Shares" in the prospectus for further details.

#### Term

This product has no fixed term.

#### **Objectives**

The fund aims to maximise the current yield on your investment through providing efficient access to broad global credit market exposure by investing in a diversified pool of fixed income securities and instruments, using prudent investment management principles.

#### Investment Policy

The fund is an actively managed portfolio which seeks to achieve its investment objective by investing at least 80% of its net assets in a diversified portfolio of fixed income instruments and securities (which are similar to loans that pay a fixed or variable rate of interest) issued by governments or companies from around the world.

The average portfolio duration of this fund will be hedged and is expected to be between negative one year and positive one year based on the investment advisor's forecast for interest rates. The fund seeks to achieve this by entering into derivative transactions to effectively convert the fixed rate interest payments into floating-rate interest payments. Such derivatives may include interest rate swaps and interest rate futures. The derivatives return is linked to movements in the underlying assets.

Duration measures the sensitivity of the assets to interest rate risk. The longer the duration the higher the sensitivity to changes in interest rates.

The securities will be both "investment grade" and "non-investment grade. "Non-investment grade" securities are generally considered to be riskier investments but may pay a higher income.

The fund may invest substantially in emerging markets, which in investment terms are those economies that are still developing.

The fund is considered to be actively managed in reference to an equally weighted blend of the following three indices at constant 0.25 year duration: Bloomberg Global Aggregate Credit ex Emerging Markets Index, ICE BofAML BB-B Rated Developed Markets High Yield Constrained Index, JPMorgan Emerging Market Bond Index ("EMBI") Global; All USD Hedged (together the "Benchmark") by virtue of the fact that the Benchmark is used for performance comparison purposes. Certain of the fund's securities may be components of and may have similar weightings to the Benchmark. However, the Benchmark is not used to define the portfolio composition of the fund or as a performance target and the fund may be wholly invested in securities which are not constituents of the Benchmark.

The fund may invest in instruments such as convertible bonds, including contingent convertible bonds, which are bonds that can be converted into shares.

The assets held by the fund may be denominated in a wide variety of currencies. The investment advisor may use foreign exchange and related derivative instruments to hedge or implement currency positions.

**Dealing Day** Shares in the fund can normally be redeemed on a daily basis. Please refer to the section entitled "How to Redeem Shares" in the prospectus.

**Distribution Policy** This share class does not pay out a distribution. Any investment income generated will be reinvested.

#### Intended retail investor

Typical investors in the Fund will be investors who are looking to maximise current yield through a combination of both income and capital growth and also seek protection against interest rate risk and are looking for a diversified exposure to global fixed income markets and are willing to accept the risks and volatility associated with investing in such markets, including emerging markets and non investment grade securities, and who have an investment horizon over the medium to long term.

# What are the risks and what could I get in return?

## Risk Indicator



The risk indicator assumes you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

This classification is subject to change over time.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the value of your investment.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
