# What is this product?

Type:

This product is a UCITS Fund.

Term:

The Fund, unless dissolved pursuant to any specific cause set forth in a mandatory law or in accordance with the prospectus of the Fund, is established for an unlimited duration.

#### **Objectives:**

The objective of the Fund is to seek to provide current income and capital appreciation.

The Fund seeks to invest in securities it identifies as being undervalued with positive risk/reward characteristics. It invests at least 80% of its net assets in income-producing debt and equity securities. At least 65% of the Fund's net assets are invested in preferred stocks and debt securities. Preferred stocks are securities issued by corporate issuers that generally pay fixed or adjustable rate distributions to investors. The debt securities in which the Fund invests may include corporate bonds, U.S. and local government securities and mortgage backed securities.

At least 50% of the Fund's net assets are invested in USD denominated securities issued by US issuers. The Fund may invest up to 50% of its net assets in USD denominated securities issued by non-US issuers. The Fund may invest up to 35% of its net assets in equity securities (excluding preferred stock). No more than 10% of the Fund's net assets may be invested in emerging markets.

The Fund may have an unlimited exposure to securities with a credit rating lower than investment grade ("high yield securities"). High yield securities have a lower credit rating because they carry a higher risk of not being paid back.

The Fund is actively managed and uses the Bloomberg U.S. Aggregate Bond Index (USD) (the "Benchmark") for performance comparison purposes. While a proportion of the Fund's assets may from time to time be components of and have similar weightings to the Benchmark, the Sub Investment Manager has discretion in the selection of investments for the Fund and may invest in securities that are not included in the Benchmark. #### Intended retail investor:

The Fund may be appropriate for investors who have a long-term investment horizon. The Fund is not designed for investors who are unwilling to accept volatility, including the possibility of sharp share price fluctuations (including declines) or investors who are seeking to invest to meet short-term goals.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the Fund's capacity to pay you.

# What happens if Carne Global Fund Managers (Ireland) Limited is unable to pay out?
