## What is this product?

### Type:

The Fund is a sub-fund of Waverton Investment Funds plc, an open-ended investment company with variable capital organised under the laws of Ireland as a public limited company pursuant to the Companies Act and authorised by the Central Bank of Ireland as a UCITS pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011.

### Term:

Open Ended Fund.

### Objectives:

The Fund aims to achieve long-term growth on your investment.

The Fund may invest up to 100% of its assets, directly or indirectly through investment in other funds, in shares of companies worldwide, bonds issued by governments or companies worldwide, structured products and in commodities through investment in other funds.

The Fund may use instruments whose value is determined by changes in the value of the underlying assets they represent (derivatives). The Fund may do so for investment purposes or in order to manage the Fund more efficiently (e.g., reducing risks or costs or generating additional growth or income).

The Fund may invest up to 30% of its assets in other funds. The Fund may not invest more than 20% of its Net Asset Value in any one collective investment scheme.

The Fund may invest no more than 30% of its assets in emerging market countries.

The Fund may invest between 60% and 90% of its assets in shares of companies worldwide, including ordinary shares and preferred shares. A preferred share typically pays dividends at a specified rate and has preference over ordinary shares in dividends and the liquidation of assets.

The Fund may invest up to 30% of its assets in structured products. These are securities in which the issuer undertakes to provide a return to investors based on the performance of a reference asset such as an equity, bond, derivative, index or fund.

The Fund may invest up to 40% of its assets in bonds issued by governments or companies worldwide and in bonds convertible into shares, each of which will be rated either investment grade or below investment grade. A rating

agency gives an investment grade rating when it believes that there is a relatively low risk that the issuer of a bond will be unable to make payments.

The Fund may invest up to 20% of its assets in bonds that are rated below investment grade.

At times, the Fund may hold cash and cash-like instruments.

You may sell your shares on any working day (generally, a day on which banks in Dublin and London are open).

The Fund declares dividends quarterly (generally, on 31 January, 30 April, 31 July and 31 October each year). Unless you request cash payment, your dividends will be paid in the form of additional shares in the Fund.

The Fund is actively managed and uses the UK Consumer Price Index +3.5% (in GBP) (the "Benchmark") and IA Mixed Investment 40-85% Shares (the "Benchmark") for performance comparison purposes only. The fund does not seek to track its benchmark and so has discretion as to the investments it may make. There can be no guarantee that the Fund will match or exceed the performance of the Benchmark.

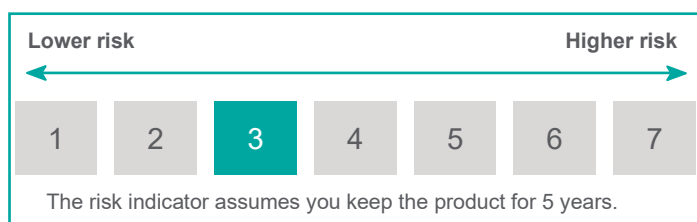
### Intended retail investor:

The Fund is suitable for investors seeking to achieve capital growth over at least a 5 year period with a moderate to high level of volatility.

Effective 15th December 2025 the London & Capital Global Growth Fund, a Sub-Fund of GemCap Investment Funds (Ireland) plc, merged and renamed into Waverton Multi-Asset Growth Fund, a Sub-Fund of Waverton Investment Funds plc.

## What are the risks and what could I get in return?

### Risk Indicator



The actual risk can vary significantly if you cash in at an early stage and you may get back less.

## What happens if FundRock Management Company (Ireland) Limited is unable to pay out?

You will not face financial loss should FundRock Management Company (Ireland) Limited default on their obligation. In the event of insolvency of the depositary, CACEIS Bank, Ireland Branch, the Fund's financial instruments are protected and are not subject to a claim by the depositary's liquidator. In the event that there is any loss, there is no compensation or guarantee scheme in place which may offset, all or any of, this loss.

For the protection of investors the fund's assets are held by an independent depositary, so the fund's ability to pay out would not be affected by the insolvency of FundRock Management Company (Ireland) Limited. If the fund is terminated or wound up, the assets will be liquidated, and you will receive an appropriate share of any proceeds but you may lose part or all of your investment. There is no compensation scheme protecting you from this scenario.

## What are the costs?

### Costs over time
