What is this product?

Type A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

Term Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

Objectives To provide total returns comprised of capital growth (i.e. to grow the value of your investment) and income over the long term, primarily through investing in a balanced portfolio of emerging markets investments.

Investment policy Invests in a mix of assets including: the shares of companies; bonds; property; commodities; transferable securities and other eligible asset classes. The issuers of these investments are either in emerging markets or those with material links to these markets. Normally, exposure to shares of companies will be no more than 75% of the value of the Fund. May invest up to 20% of its value in mainland China, including bonds traded on the China Interbank Bond Market and companies traded on Stock Connect. The Fund may invest in other assets and may hold cash.

Derivatives and techniques Derivatives may be used to achieve the Fund's investment objectives, to manage the Fund's risks or reduce the costs of managing the Fund.

Benchmark(s) The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives. The 50% MSCI Emerging Markets Net Return, 25% JPMorgan GBI-EM Global Diversified (Net of Tax Return), 25% JPMorgan EMBI Global Diversified Index is used for performance comparison and risk management. The Fund does not seek to replicate the index. It will generally hold assets that are components of the index, but not in the same proportions, and it is allowed to hold assets which are not components of the index. The Fund will therefore generally look different from the index, and the Investment Manager will monitor performance differences. **Practical details** The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is reflected in the value of your shares. Glossary of terms

Bonds Tradable contracts issued by governments or companies to repay borrowed money and typically pay interest at fixed periods. **Derivatives** Financial contracts whose value is linked to the price of an underlying asset.

Emerging market Low-income countries that are less developed than major economies.

SFDR The Sustainable Finance Disclosure Regulation seeks to strengthen and standardise disclosures on the Environmental, Social and Governance ('ESG') characteristics of EU financial products.

Stock Connect A share trading link between the Hong Kong Stock Exchange and mainland Chinese equity markets.

Transferable securities Financial instruments, such as shares or bonds, which are tradable on capital markets.

Intended retail investor:

This Fund has been designed to form part of a broader portfolio of investments, but may also be suitable as a significant component of an investors overall portfolio and should be purchased with advice or on an execution only basis by a basic investor. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep this product for at least 5 years. The actual risk can vary significantly if you sell at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 3 out of 7, which is a mediumlow risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to reduce the value of your investment.

Be aware of currency risk. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance scenarios

What are the costs?

Costs over time
