CBOE S&P 500 15% WHT Quarterly 5% Buffer Protect Index	The Cboe S&P 500 15% WHT Quarterly 5% Buffer Protect Index (SPBFQ) is designed to provide protection against losses of 5% due to a decline in the S&P 500 NTR (15%) while providing participation up to a capped level. This strategy consists of a “long” exposure to the S&P 500 NTR (15%) (SPX15UN) and a long S&P 500 Index (SPX) put spread vs. short call expiring quarterly on the last business day of March, June, September, and December.
