The Fund aims to generate a total return over the long term through a combination of income and capital by investing in global corporate and government bonds, from investment grade to high yield, with at least 80% of the Fund's assets allocated to developed markets. The Fund considers environmental, social and governance (ESG) characteristics of issuers.



*The Ongoing Charges Figure (OCF) covers all aspects of operating a fund during the course of its financial year. These include the annual charge for managing the fund, administration and independent oversight functions, such as trustee, depository, custody, legal and audit fees and the ongoing costs of underlying investments including open and closed ended collective investment schemes. The OCF excludes portfolio transaction costs except for an entry/exit charge paid by the Fund when buying or selling units in another fund.
