There is currently no charge for switching funds, however the number of switches is limited to a max of one per calendar month.

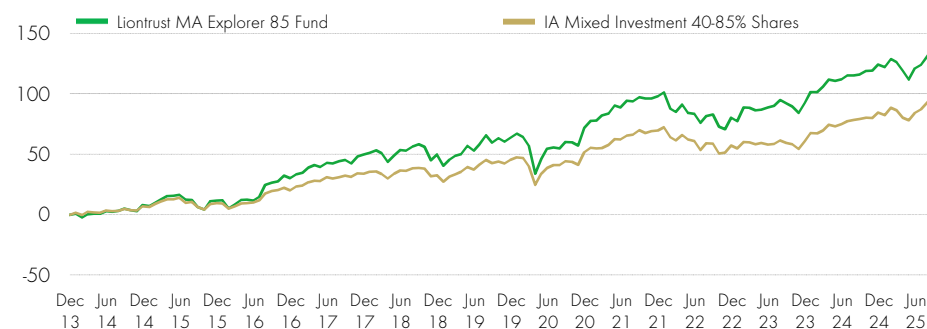

### PERFORMANCE SINCE CLASS LAUNCH DATE (%)



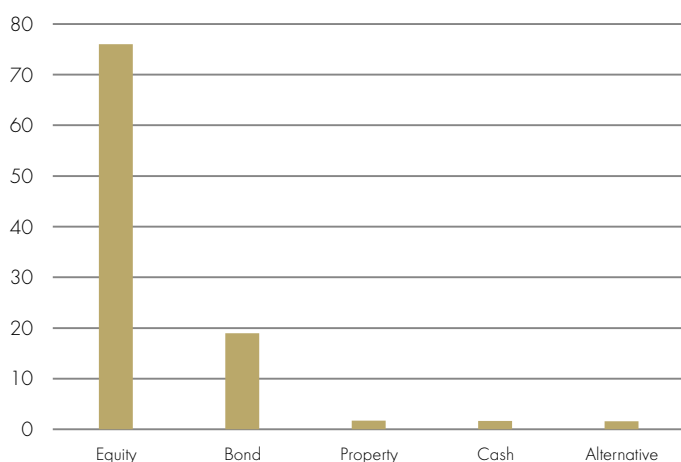
