The fund managers seek to take advantage of market inefficiencies.

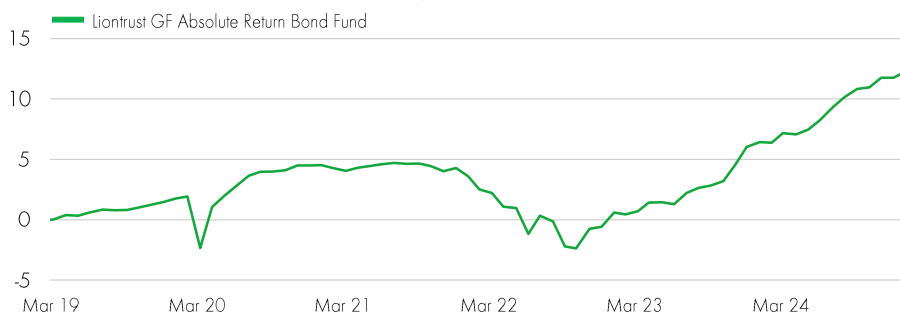

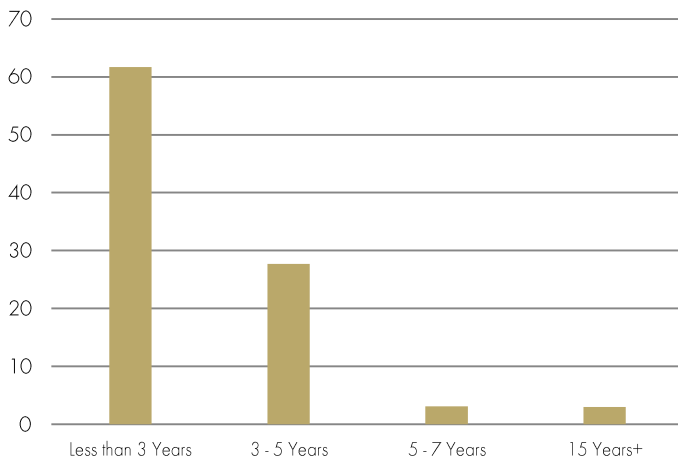

*The Ongoing Charges Figure (OCF) covers all aspects of operating a fund during the course of its financial year. These include the annual charge for managing the fund, administration and independent oversight functions, such as trustee, depository, custody, legal and audit fees and the ongoing costs of underlying investments including open and closed ended collective investment schemes. The OCF excludes portfolio transaction costs except for an entry/exit charge paid by the Fund when buying or selling units in another fund. RISK AND REWARD PROFILE



- The Fund is categorised 2 primarily for its exposure to a diversified portfolio of bonds along with a number of derivative positions.
- The SRI may not fully take into account the following risks:

 - Bonds are affected by changes in interest rates and their value and the income they generate can rise or fall as a result;
