## What is this product?

**Type** A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

**Term** Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

**Objectives** To provide total returns comprising of a high level of income with the opportunity for capital growth (i.e. to grow the value of your investment) over the long term. Targets a return in excess of Overnight SOFR +4% gross of fees over a full credit cycle (the phases of access to credit by borrowers). Credit cycles can vary in length and typically last between 3 and 7 years. While the Fund aims to achieve a positive return and its performance target, there is no guarantee that either will be achieved over the full credit cycle, or over any period of time. There is no guarantee that all capital invested in the Fund will be returned.

**Investment policy** Invests primarily in a diverse portfolio of bonds, deposits or derivatives. These securities are issued by governments, institutions or companies from around the world including emerging markets. Investments priced in currencies other than US dollars will be hedged back into US dollars. May invest up to 20% of its value in Structured Credit Instruments, including collateralised loan obligations, mortgage-backed securities and asset backed securities. Investment in Contingent Convertible securities (CoCos) and distressed debt will not exceed 20% of the assets of the Fund. Investment in distressed debt will not exceed 10% of the assets of the Fund. The Fund may invest in other assets and may hold cash.

**Strategy** When selecting issuers, factors such as credit quality, duration, liquidity, geographic location and industry sector will all be considered as part of the portfolio construction process.

**Sustainability approach – Article 8 SFDR** The Fund promotes environmental and social characteristics in line with Article 8 of the EU Sustainable Finance Disclosure Regulation (SFDR) by promoting better carbon outcomes (i.e. maintaining a carbon profile lower than typical global credit indices) by making investments in borrowers that meet the standards of the Investment Manager's proprietary sustainability frameworks and by excluding direct investments in certain sectors or business areas (that are deemed to have less favourable sustainability characteristics).

**Derivatives and techniques** Derivatives may be used to achieve the Fund's investment objectives, to manage the Fund's risks or reduce the costs of managing the Fund.

**Benchmark(s)** The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives. The Fund cannot replicate the target benchmark index. The benchmark index is not investable and therefore cannot be replicated. The assets of the Fund therefore will not resemble the components of the index.

**Practical details** The Fund's returns depend on the performance of its underlying investments and it does

not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is reflected in the value of your shares. ### Glossary of terms

- Bonds** Tradable contracts issued by governments or companies to repay borrowed money and typically pay interest at fixed periods.
- Contingent Convertible securities (CoCos)** Bonds that convert into shares if a pre-defined trigger event occurs.
- Derivatives** Financial contracts whose value is linked to the price of an underlying asset.
- Distressed debt** Bonds whose issuers are in financial difficulty and trading significantly below face value.
- Emerging market** Low-income countries that are less developed than major economies.
- Hedging** An investment technique which aims to protect the value of an investment against currency movements.
- SFDR** The Sustainable Finance Disclosure Regulation seeks to strengthen and standardise disclosures on the Environmental, Social and Governance ('ESG') characteristics of EU financial products.
- Structured Credit Instruments** Financial products that package pools of income-producing assets, such as mortgages, car loans, or corporate debt, into tradable securities. Examples include collateralised loan obligations, mortgage-backed securities and asset-backed securities.

## Intended retail investor:

This Fund has been designed to form part of a broader portfolio of investments and should be purchased with advice or on an execution only basis by a basic investor. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.

## What happens if Ninety One Luxembourg S.A. is unable to pay out?

## What are the costs?

### Costs over time

If you sell before the end of the recommended holding period, this will increase the risk of lower investment returns or a loss.
