This will have an impact on the realisable value of the investment, particularly in the short term. ²These are the annual costs of running and managing the Fund. There is currently no charge for switching funds, however the number of switches is limited to a max of one per calendar month.

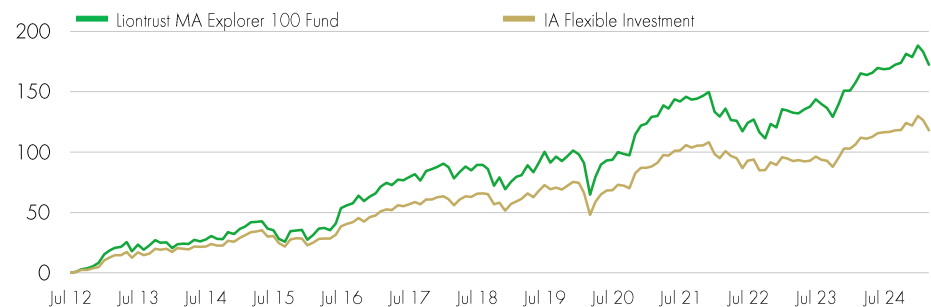

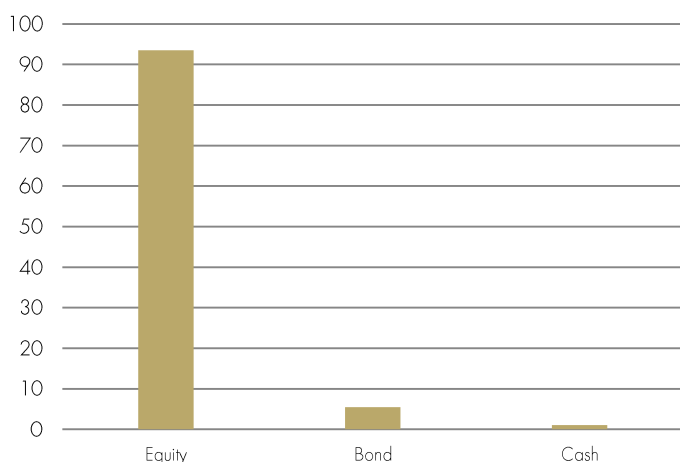
