Objectives and Investment Policy

Objectives

The investment objective of the Sanlam Global Bond Fund (the Fund) is to generate an income and to increase the value of your shares over the long term.

Investment policy

The Fund is actively managed and shall invest globally in debt securities and money market instruments. Debt securities are any debt instrument which can be bought or sold between two parties with basic terms as to amount borrowed, interest rate and maturity defined. Money market instruments are highly liquid and generally mature over the short term. The Fund may also invest in collective investment schemes (CIS) and exchange traded funds (ETF) which invest in money market instruments. The debt securities and money market instrument which the Fund invests in are principally of investment grade. The Fund may also invest in cash or in instruments which have the same effect as investing in cash to ensure that the Fund retains its ability to deal with redemptions as they fall due. The Fund may use financial derivative instruments (FDI) for efficient portfolio management purposes only. FDI are financial instruments the value of which is linked to the expected future price movements of underlying assets.

A maximum of 15% of the Fund value may be invested in emerging markets.

The Fund shall measure its performance relative to a benchmark index (the Bloomberg Barclays Global Aggregate Index - USD Hedged) for reference or investor communication purposes, including in the Company's annual and half-yearly reports. This benchmark index is also

the reference portfolio for the purposes of the relative VaR for global exposure calculation for risk management purposes. The Fund shall be managed in reference to this benchmark index to the extent that the VaR of the Fund shall not exceed twice the VaR of the reference portfolio to ensure global exposure of the Fund does not exceed 100% of the Fund's Net Asset Value under normal market conditions. Accordingly, debt and money market securities into which the Fund invests shall be listed or traded on a regulated market in countries contained within the Benchmark.

You can buy or sell your shares in the Fund any day (except Saturday or Sunday) that banks are open in Dublin.

The Company does not currently declare a dividend in relation to your shares and therefore any income that your shares may earn will be retained within the Fund and the value of your shares will rise accordingly.

Recommendation: The Fund is suitable for investors with a time horizon of 3 years.

Why is this Fund in category 4?

The Fund is rated 4 due to the nature of its investments which include the risks listed below. These factors may impact the value of the Fund's investments or expose the Fund to losses.

The Fund may invest in companies based in emerging markets which may involve additional risks not typically associated with other more established markets such as increased risk of social, economic and political uncertainty.

Investing in a CIS or ETF may lead to payment by the Fund of additional fees and expenses in relation to those CIS or ETF. It may be difficult for the Fund in extreme market conditions to redeem its shares from a CIS or ETF at short notice without suffering a loss. Companies or governments issuing the debt may become insolvent or suffer financial difficulties. The debt securities may in some cases be below investment grade, which means that while they may deliver a higher return, there is potentially a higher risk of default and loss to the fund.

What do these numbers mean?

They rate how a fund might behave and how much risk there is to your capital. Generally, the chance to make large gains means a risk of suffering large losses.

A **Category 1** fund is not a risk-free investment - the risk of losing your money is small, but the chance of making gains is also limited. With a **Category 7** fund, the risk of losing your money is high but there is also a chance of making higher gains. The seven-category scale is complex (for example, 2 is not twice as risky as 1).

More about this rating:

This rating system is based on the average fluctuations of the prices of funds over the past 5 years - that is, by how much the value of their assets taken together has moved up and down. Historical data, such as is used in calculating the synthetic risk indicator, may not be a reliable indication of the future risk profile of the Fund.

Charges
