What is this product?

Type A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

Term Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

Objectives To provide income and grow the value of your investment over the long term.

Investment policy Invests around the world in a mix of different assets including bonds, money market instruments, the shares of companies; convertible securities; and other funds. The Fund may hold cash. Normally, exposure to shares of companies will be no more than 75% of the value of the Fund. May invest up to 20% of its value in mainland China, including bonds traded on the China Interbank Bond Market and companies traded on Stock Connect. The portfolio's value at risk (risk of capital loss) will be managed relative to that of a composite index of 60% MSCI AC World Net Return Index + 40% BofAML Global Government Index. This index is not relevant for performance comparison purposes.

Strategy Uses a flexible approach to asset allocation, using a broad range of asset classes and investment techniques which allows the Investment Manager to respond effectively to market conditions and investment opportunities. Investment opportunities are identified using macroeconomic analysis and research.

Derivatives and techniques Derivatives may be used to achieve the Fund's investment objectives, to manage the Fund's risks or reduce the costs of managing the Fund.

Benchmark(s) The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives. The 60% MSCI AC World Net Return, 40% FTSE WGBI Index is used for performance comparison. The Fund does not seek to replicate the index. It will generally hold assets that are components of the index, but not in the same proportions, and it is allowed to hold assets which are not components of the index. The assets of the Fund therefore may be very different from the index.

Practical details The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is reflected in the value of your shares. You may switch between GSF funds or share classes of the same fund; details are in the 'Conversion of Shares' section of the prospectus. Glossary of terms

Bonds Tradable contracts issued by governments or companies to repay borrowed money and typically pay interest at fixed periods.

Derivatives Financial contracts whose value is linked to the price of an underlying asset.

Money market instruments Investments usually issued by banks or governments that are a short term loan to the issuer by the buyer. The buyer receives interest and the return of the original amount at the end of a certain period.

Stock Connect A share trading link between the Hong Kong Stock Exchange and mainland Chinese equity markets.

Intended retail investor:

This Fund has been designed to form part of a broader portfolio of investments, but may also be suitable as a significant component of an investors overall portfolio and should be purchased with advice or on an execution only basis by a basic investor. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep this product for at least 5 years. The actual risk can vary significantly if you sell at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could reduce the value of your investment.

Be aware of currency risk. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Recommended holding period We recommend that you hold this investment for at least 5 years as the Fund is designed to be held over the long term.

If you sell before the end of the recommended holding period, this will increase the risk of lower investment returns or a loss.
