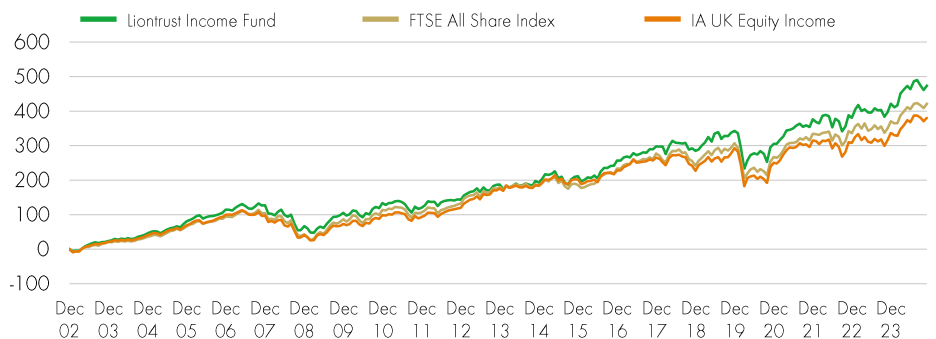

- The Fund is categorised 6 primarily for its exposure to UK equities.
