What is this product?

Type:

- This product is a UCITS Fund.
- The Company has appointed The Bank of New York Mellon SA/NV, Dublin Branch, to act as the depository of the Company's assets pursuant to the Depository Agreement

Term:

- This investment has no fixed maturity date.
- The Fund may be terminated at any time in line with the constitutional documents of the plc.

Objectives:

- The Fund aims to achieve a positive absolute return over the long term for investors through a portfolio of long, synthetic long and synthetic short investments primarily in European equities and equity related derivatives. There is no guarantee that a positive absolute return will be generated over any time period. The Fund invests globally, although it is intended to invest primarily in Developed European equities. The Fund may also invest in other eligible asset classes as detailed within the prospectus. The Fund will invest in derivatives but it is not intended that their use will materially affect volatility. Derivatives are used to protect against currencies, credit and interest rate moves or for investment purposes. The use of derivatives may create leverage or gearing resulting in potentially greater volatility or fluctuations in the net asset value of the Fund. A relatively small movement in the value of a derivative's underlying investment may have a larger impact, positive or

negative, on the value of a fund than if the underlying investment was held instead. The Fund is considered to be actively managed in reference to MSCI Europe Index and the HFRX Equity Hedge (EUR) Index (the "Benchmarks") by virtue of the fact that it uses the Benchmarks for performance comparison purposes. The Benchmarks are not used to define the portfolio composition of the Fund and the Fund may be wholly invested in securities which are not constituents of the Benchmarks.

- The fund managers focus on the historic cash flows generated and invested by companies to support their forecast profits growth. As forecasts are often unreliable, the scale of cash invested to support forecasts is key. The fund managers seek to own companies that generate significantly more cash than they need to sustain their planned growth yet are lowly valued by investors on that measure and are run by managers committed to an intelligent use of capital. They sell short stocks that their research indicates are expensive, are struggling to generate any cash and are run by management investing heavily for future growth.
- **Dealing Frequency:** Shares in the Fund can be bought and sold, either in whole or in part, every business day. An application must be submitted to the administrator, BNY Mellon Fund Services (Ireland) LIMITED, by 11:59 am on the business day of the purchase or sale.

Intended retail investor:

- The Fund is considered to be suitable for investors seeking long-term capital growth over a medium to long term investment horizon (at least 5 years) and who understand and are prepared to accept the risks and a medium to medium/high level of volatility, particularly given the Fund's equity investment.

What are the risks and what could I get in return?

Risk Indicator

How long should I hold it and can I take money out early?

- Recommended holding period: 5 years**
- The Fund has daily liquidity. The recommended holding period of the Fund assumes the Fund being the sole or majority holding of the investor. The recommended holding period is primarily based on the historic volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The fund is not intended for short term speculation purposes. In order to divest/redeem from the Fund you can send a completed signed redemption form by 11:59am (Irish time) on a daily basis (but not weekends or Bank Holidays).
