### What is this product?

Type This product is a UCITS sub-fund of a variable capital umbrella investment company with segregated liability between sub-funds authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended.

Subject to the conditions set down in the prospectus, shareholders may exchange all or part of their shares of this fund for shares of another fund of the company. Please refer to the section entitled "How To Exchange Shares" in the prospectus for further details.

Term This product has no fixed term.


Objectives The fund aims to maximise the total return on your investment through primarily investing in a range of euro-denominated fixed income securities and instruments, using prudent investment management principles.

#### Investment Policy

Investment Policy The fund aims to achieve this objective by investing primarily in a range of "investment grade" fixed income securities and instruments (which are similar to loans that pay a fixed or variable rate of interest) issued by companies or governments from around the world and mainly priced in euros. The fund is considered to be actively managed in reference to the FTSE Euro Broad Investment-Grade Index (the "Index") by virtue of the fact that the Index is used for duration measurement, calculating the global exposure of the fund using the relative VaR methodology and for performance comparison purposes. Certain of the fund's securities may be components of and may have similar weightings to the Index.

### What are the risks and what could I get in return?

#### **Risk Indicator**



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

However, the Index is not used to define the portfolio composition of the fund or as a performance target and the fund may be wholly invested in securities which are not constituents of the Index

The average portfolio duration of this fund will normally vary within two years (plus or minus) of the Index. Duration measures the sensitivity of the assets to interest rate risk. The longer the duration the higher the sensitivity to changes in interest rates. The fund may invest up to 10% in "non-investment grade" securities. Non-investment grade securities are considered to be more risky, but typically produce a higher level

of income

The fund may invest in emerging markets, which in investment terms are those economies that are not as developed. The fund will promote environmental and social characteristics through an exclusion

strategy and, where applicable, issuer engagement. The fund may invest in derivative instruments (such as futures, options and swaps) rather than directly in the underlying securities themselves. The derivatives return is linked to movements in the underlying assets

The assets held by the fund may be denominated in a variety of currencies. The investment advisor may use foreign exchange and related derivative instruments to

hedge or implement currency positions. **Dealing Day** Shares in the fund can normally be redeemed on a daily basis. Please refer to the section entitled "How to Redeem Shares" in the prospectus.

Distribution Policy This share class does not pay out a distribution. Any investment income generated will be reinvested.

#### Intended retail investor

ypical investors in the Fund will be investors who are looking to maximise total return through a combination of both income and capital growth and are looking for a diversified exposure to primarily European fixed income markets and who are willing to accept the risks and volatility associated with investing in such markets and who have an investment horizon over the medium to long term.

#### This classification is subject to change over time.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the value of your investment.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
