What is this product?

Type A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

Term Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

Objectives To provide total returns comprised of income and capital growth (i.e., to grow the value of your investment). Targets a return in excess of ICE BofA US 3-month Treasury Bill Index (gross of fees) over rolling 5-years periods.

Investment policy Invests to express views across a broad range of currencies in developed and emerging markets. The assets used will principally be derivatives and may also include, sovereign Investment Grade bonds, money market instruments, deposits, commodities (e.g. gold) and units or shares in other funds. The Fund may hold cash. May from time to time invest in mainland China without limitation, including bonds traded on the China Interbank Bond Market.

Strategy The strategy is based on the belief that currencies experience significant short-term noise but establish long-term trends. The process involves the identification and precise implementation of high conviction risk/reward opportunities. Positions are implemented principally through derivatives.

Derivatives and techniques Derivatives may be used to achieve the Fund's investment objectives, to manage the Fund's risks or reduce the costs of managing the Fund.

Benchmark(s) The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives. The Fund does not seek to replicate the target benchmark index. At times it may hold assets that are components of the index and assets which are not components of the index. The assets of the Fund therefore may be very different from the index. **Practical details** The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is reflected in the value of your shares. Glossary of terms

Actively Managed Where the fund manager uses their expertise to pick investments to achieve the fund's objectives.

Bonds Tradable contracts issued by governments or companies to repay borrowed money and typically pay interest at fixed periods.

Derivatives Financial contracts whose value is linked to the price of an underlying asset.

Emerging market Low-income countries that are less developed than major economies.

Investment Grade Bonds considered of the highest quality by credit rating agencies (typically BBB or higher).

Money market instruments Investments usually issued by banks or governments that are a short term loan to the issuer by the buyer. The buyer receives interest and the return of the original amount at the end of a certain period.

Intended retail investor:

The Fund has been designed to form part of a broader portfolio of investments, but may also be suitable as a significant component of an investor's overall portfolio and can be purchased with advice or on an execution only basis by a basic investor. This share class of the Fund is only available to an investor that qualifies as an 'institutional investor' under Luxembourg administrative practice and can be purchased with advice, on an execution only basis or when providing portfolio management services. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep this product for at least 5 years. The actual risk can vary significantly if you sell at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 3 out of 7, which is a mediumlow risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to reduce the value of your investment.

Be aware of currency risk. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
