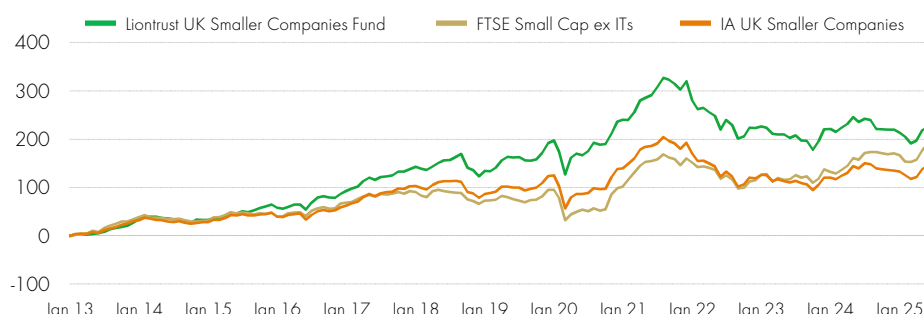

RISK AND REWARD PROFILE



- The Fund is categorised 6 primarily for its exposure to UK small cap equities.
- The SRRI may not fully take into account the following risks:
