## What is this product?

**Type** A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

**Term** Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

**Objectives** To provide income with the opportunity to grow the value of your investment over the long term.

Investment policy Invests primarily in a range of bonds issued by emerging market companies and in related derivatives. At least 90% of the bonds invested in are of investment grade as rated by the credit rating agencies. These bonds are issued in either the currency of the country in which they are issued or in globally traded major currencies. May invest up to 10% of its value in frontier markets and investment in distressed debt will not exceed 10% of the assets of the Fund. The Fund may invest in other assets and may hold cash.

Sustainability approach – Article 8 SFDR The Fund promotes environmental and social characteristics in line with Article 8 of the EU Sustainable Finance Disclosure Regulation (SFDR) by making investments in borrowers that meet the standards of the Investment Manager's proprietary sustainability framework and by excluding investments in certain borrowers.

**Derivatives and techniques** Derivatives may be used to achieve the Fund's investment objectives, to manage the Fund's risks or reduce the costs of managing the Fund.

Benchmark(s) The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives. The JPMorgan CEMBI Broad Diversified Investment Grade Index is used for performance comparison and risk management. The Fund does not seek to replicate the index. It will generally hold assets that are components of the index, but not in the same proportions, and it is allowed to hold assets which are not components of the index. The Fund will therefore generally look different from the index, and the Investment Manager will monitor performance differences.

Practical details The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is paid out to you. English, French and German language copies of the GSF prospectus, annual and semi-annual reports and share prices may be obtained free of charge from www.ninetyone.com. GSF's Depositary is State Street Bank International GmbH, Luxembourg Branch. The assets and liabilities of the Fund are segregated under Luxembourg law and an investment in the Fund cannot be used to meet the debts or, claim against, any other person, including any other GSF sub-fund. You may switch between GSF funds or share classes of the same fund; details are in the 'Conversion of Shares' section of the prospectus. #### Glossary of terms

**Bonds** Tradable contracts issued by governments or companies to repay borrowed money and typically pay interest at fixed periods.

**Credit rating agencies** Companies that rate the ability of the issuers of bonds to repay borrowed money.

**Derivatives** Financial contracts whose value is linked to the price of an underlying asset.

**Distressed debt** Bonds whose issuers are in financial difficulty and trading significantly below face value.

**Emerging and frontier markets** Low-income countries that are economically less developed than major economies.

**Investment Grade** Bonds considered of the highest quality by credit rating agencies (typically BBB or higher).

SFDR The Sustainable Finance Disclosure Regulation seeks to strengthen and standardise disclosures on the Environmental, Social and Governance ('ESG') characteristics of EU financial products.

This Fund has been designed to form part of a broader portfolio of investments and should be purchased with advice or on an execution only basis by a basic investor. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.
