What is this product?

Type: This product is a UCITS fund authorised in Ireland and regulated by the Central Bank of Ireland.

Term: This product is not subject to any fixed term.

Objectives:

Objectives and Investment Policy This product aims to maximise a total return consisting of current income and capital appreciation. Under normal market conditions, the Fund invests at least 80% of its net assets (a) directly in non-U.S. government debt securities from developed and emerging markets, corporate debt securities from developed and emerging markets, U.S. government and agency or permitted supranational agency securities, issued or guaranteed investment grade or high yield debt securities, U.S. high-yield bonds, investment grade corporate bonds and currency instruments, preferred stocks and real estate investment trusts and securities convertible at the option of the Fund in to common stock (or other equity), and asset-backed and mortgage-backed securities and (b) indirectly through specialist financial techniques (known as derivatives). The fund may use derivatives for hedging, efficient portfolio management and leverage. The use of derivatives may introduce dynamic leverage to the Fund. The level of leverage will vary depending on a number of factors including the type of derivative instrument acquired by the Fund, position size, and tenor. While the Fund's gross leverage, calculated on the basis of the sum of the notional values of the derivatives is expected to be between 80% and 325% and while it may be subject to higher levels of leverage at times, it is not expected to exceed 1800% of the Fund's Net Asset Value. This is not, however, an indicator of economic leverage. Through the measurement and monitoring of all exposures relating to the use of derivatives on at least a daily basis, the Fund's Value at Risk will not exceed 20% of the Fund's Net Asset Value. While it is intended to limit the exposure to below investment grade securities in order to maintain an average credit quality rating of the portfolio to investment grade, the Fund may invest up to 40% in emerging markets and may invest up to 10% of Net Asset Value in contingent convertible securities (CoCos).

Fund Benchmark The Fund employs an actively managed investment strategy. The Fund uses the Bloomberg U.S. Aggregate Bond Index as a benchmark for performance comparison purposes only and does not track the performance of the benchmark, but is managed in reference to a benchmark.

Dealing Frequency You may buy and sell shares on any day on which the Irish Stock Exchange and New York Stock Exchange are open for regular business. The Fund holiday calendar is available from the Administrator.

Distribution Policy This share class does not pay out a distribution. Any investment income generated will be reinvested.

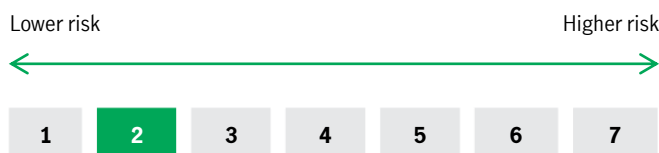

Intended retail investor:

This product is designed to be purchased with advice and should form part of a broader portfolio of investments. The product is suitable for investors including those with a basic knowledge of financial instruments, who are comfortable with the level of risk in the risk indicator section. Investors must be able to bear capital loss and should have an investment time horizon of at least five years.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level and poor market conditions are very unlikely to impact the ability for you to receive a positive return on your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance scenarios

The figures shown include all the costs of the product itself but may not include all the costs that you pay to your advisor or distributor. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of this share class (where the class has been in existence under 10 years, supplemented by the performance of another class of the Fund with an earlier inception date, if appropriate, and further, by the share class benchmark where necessary to complete a period of 10 years). The stress scenario shows what you might get back in extreme market circumstances. The unfavourable scenario occurred for an investment between May 2021 and June 2023, the moderate scenario occurred for an investment between February 2014 and February 2019, and the favourable scenario occurred for an investment between December 2015 and December 2020.

What happens if Manulife Investment Management (Ireland) Limited is unable to pay out?

The Fund does not include any protection from future market performance, so you could lose some or all of your investment. These losses may be covered by the Irish Investor Compensation Company DAC, subject to certain limitations. However, your investments are deposited with a third party custodian bank, which means that in case of default of Manulife Investment Management (Ireland) Limited, you should be able to get back the current value of your investment.

What are the costs?

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment. Since the value of investments can rise and fall over differing time periods, you should have an investment horizon of at least 5 years when buying an investment of this type.

The minimum recommended holding period is therefore 5 years. You can request to take out some or all of your money at any time. You can typically request to buy or sell shares in the Fund on any business day (as set out in the Fund's prospectus).
