Objectives & Investment Policy

The aim is to maximise long-term total return.

The Fund is actively managed which means that the Investment Manager is actively making investment decisions for the Fund. The Fund is not managed in reference to a benchmark.

The Fund primarily invests in shares of companies traded in global developed markets. The Fund is designed to purchase securities of large global developed market companies that the Investment Manager determines to have high profitability relative to other large capitalization companies in the same country or region, at the time of purchase. In assessing profitability, the Investment Manager may consider different ratios, such as that of earnings or profits from operations relative to book value or assets. The criteria the Investment Manager uses for assessing profitability are subject to change from time to time.

The composition of the Fund may be adjusted based on considerations such as the number of outstanding shares of public companies that are freely available to the investing public, the tendency of the price of a security/share to continue movement in a single direction, how readily available the shares are to buy and sell, liquidity management, size, value, profitability and investment characteristics.

The environmental and sustainability impact considerations seek to

identify factors that the Investment Manager believes indicate whether or not a company, as compared to other companies with similar business lines, promotes environmental and sustainability interests by pursuing economic growth and development that meets the needs of future generations.

The Fund may invest up to 20% of its net assets in emerging markets countries.

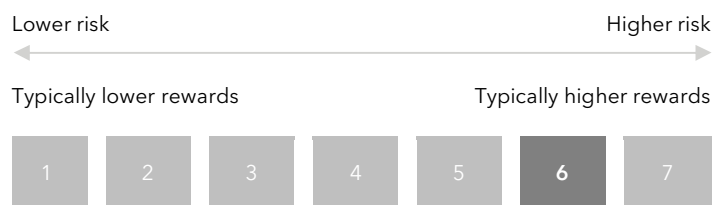
The Fund may use financial contracts or instruments (derivatives) to manage risk, reduce costs or improve returns.

Fund returns are primarily determined by the returns of the securities the Fund invests in, after fees. The performance of an investment in the Fund will be driven by the performance of the equity markets which the Fund focuses on, by the characteristics that the Fund emphasizes—such as exposure to the size, value and profitability premiums—as well as by implementation costs.

Income is not distributed and is rolled up (accumulated) into the value of your investment.

You may sell your investment in the Fund on demand on a daily basis.

Risk and Reward Profile

The Fund is in Category 6 because of the high range and frequency of price movements (volatility) of the underlying investments referenced by the Fund.

The Fund may invest up to 5% of its assets in other underlying funds. The Fund's performance, costs and risks will be affected by the underlying funds. There can be no assurance that an underlying fund will achieve its investment objective.

The Fund's investments are subject to issuer-specific risks, market risks, economic or political risks that may cause the share prices to fluctuate over time. This can affect the value of your investment in the Fund.

The assets in which the Fund invests may be denominated in or have exposure to a currency other than the currency of the shares in the Fund or of the country in which you live. Additionally, the currency of the shares you hold may be denominated in a currency different to the base currency of the Fund. The Fund does not actively manage movements in the value of currencies and currency fluctuations may affect the value of the Fund's assets.

The Fund may seek to identify and invest in high profitability shares, which are (in the Investment Manager's view) shares, where the issuing companies profits are high when compared to their accounting values. High

profitability shares may perform differently from the market as a whole and following a high profitability oriented investment strategy may cause the Fund, at times, to underperform funds that use other investment strategies.

The Fund's sustainability impact considerations may limit the number of investment opportunities available, and as a result, at times may produce different returns or more modest gains than funds that are not subject to such special investment conditions. Sustainability impact considerations may cause a Fund's industry allocation to deviate from that of funds without these considerations and of conventional benchmarks.

Where the Fund uses futures or forward foreign currency contracts (derivatives), it may become exposed to certain investment risks including leverage, market, mismatching of exposure and/or counterparty risk, liquidity, interest rate, credit and management risks and the risk of improper valuation. While the Fund is not expected to have exposure to leverage to a material degree, any movement in the price of these investments can have a significant impact on the value of the Fund and the Fund could lose more than the amount invested.

The Fund invests in emerging markets which may be less economically or politically developed and can involve greater risks than well developed economies. Amongst other issues, decreased liquidity, political unrest and economic downturn may be more likely and could affect the value of your investment. Investment in emerging markets can be more expensive and challenging to buy, sell and withdraw investments. Investments in emerging markets also have an increased risk of settlement default.

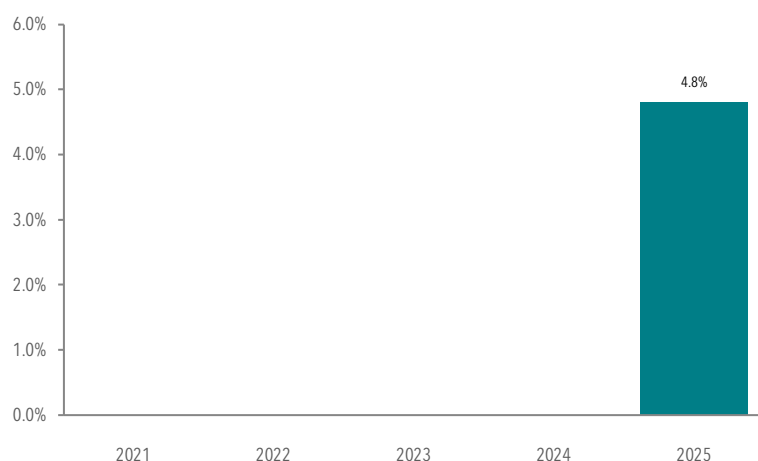
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser or distributor.
