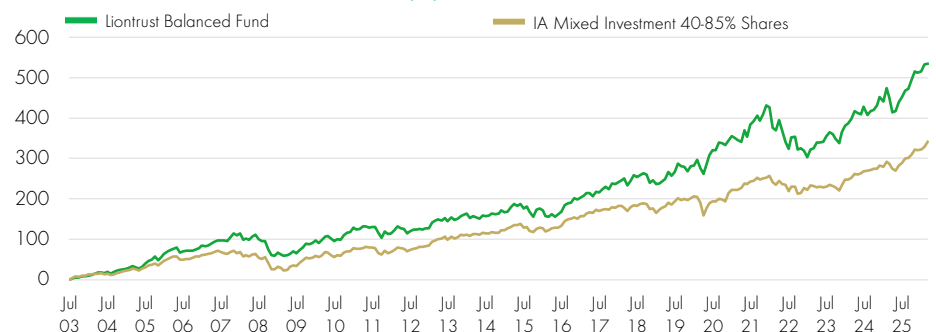

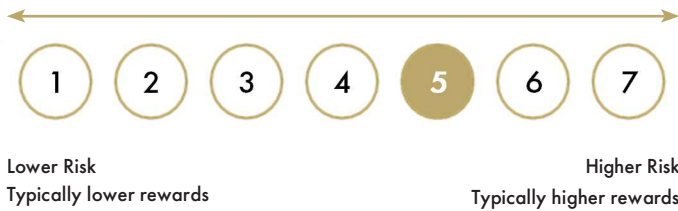

The OCF excludes portfolio transaction costs except for an entry/exit charge paid by the Fund when buying or selling units in another fund. RISK AND REWARD PROFILE



- The Fund is categorised 5 primarily for its exposure to global equities and bonds.
