# What is this product?

#### Type:

- This product is a UCITS Fund.
- The Company has appointed The Bank of New York Mellon SA/NV, Dublin Branch, to act as the depositary of the Company's assets pursuant to the Depositary Agreement

#### Term:

- This investment has no fixed maturity date.
- The Fund may be terminated at any time in line with the constitutional documents of the plc.

#### Objectives:

The Fund aims to maximise total returns (a combination of income and capital growth) over the long term (five years or more) through investment in sustainable securities, primarily consisting of European investment grade fixed income securities. There is no guarantee that a total return will be generated over any time period. The Fund invests in Euro or non-Euro investment grade corporate bonds that are hedged back into Euros. The Fund may also invest in other eligible asset classes as detailed within the prospectus. All investments will be expected to conform to our social and environmental criteria. The Fund may, under certain circumstances, invest in derivatives but it is not intended that their use will materially affect volatility. Derivatives are used to protect against currencies, credit and interest rate moves or for investment purposes. The use of derivatives may create leverage or gearing resulting in potentially greater volatility or fluctuations in the net asset value of the Fund. A relatively small movement in the value of a derivative's underlying investment may have a larger impact, positive or negative, on the value of a fund than if the underlying investment was held instead. The Fund is considered to be actively managed in reference to IBOXX Euro Corporate All Maturities (the "Benchmark") by virtue of the fact that it uses the benchmark(s) for performance comparison purposes. The benchmark(s) are not used to define the portfolio composition of the

Fund and the Fund may be wholly invested in securities which are not constituents of the benchmark.

- Macroeconomic analysis is used to determine the team's top-down view of the world and this helps shape all aspects of portfolio construction and appetite for risk. After this the managers aim to focus on high quality issuers and believe this can reduce bond specific risk. The fund managers' assessment of quality is a distinctive part of the process, in which they combine traditional credit analysis with a detailed sustainability assessment based on the proprietary model. The managers assess individual bonds for whether they believe they offer attractive longterm returns and for absolute and relative valuations. The managers seek the best value bonds issued by the high-quality issuers identified, looking at bonds issued across the capital structure, along the maturity curve, or issued into the primary credit markets (UK, US and Europe). Sustainability analysis is fully integrated into the investment process helping to identify high-quality companies that the managers believe will both enhance returns and reduce issuer specific tail-risk.
- Dealing Frequency: Shares in the Fund can be bought and sold, either in whole or in part, every business day. An application must be submitted to the administrator, BNY Mellon Fund Services (Ireland) LIMITED, by 11:59 am on the business day of the purchase or sale. 
#### Intended retail investor:

 The Fund is considered to be suitable for investors seeking long-term capital growth over a medium to long term investment horizon (at least 5 years) and who understand and are prepared to accept the risks and a medium to medium/high level of volatility, particularly given the Fund's equity investment.



# What are the risks and what could I get in return?

### **Risk Indicator**

# What happens if Bridge Fund Management Limited is unable to pay out?

# How long should I hold it and can I take money out early?

#### • Recommended holding period: 5 years

- The Fund has daily liquidity. The recommended holding period of the Fund assumes the Fund being the sole or majority holding of the investor. The recommended holding period is primarily based on the historic volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The fund is not intended for short term speculation purposes. In order to divest/redeem from the Fund you can send a completed signed redemption form by 11:59am (Dublin time) on a daily basis (but not weekends or Bank Holidays).
