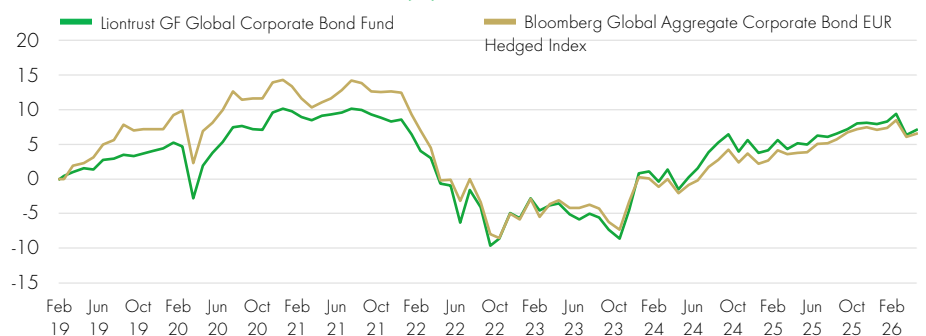

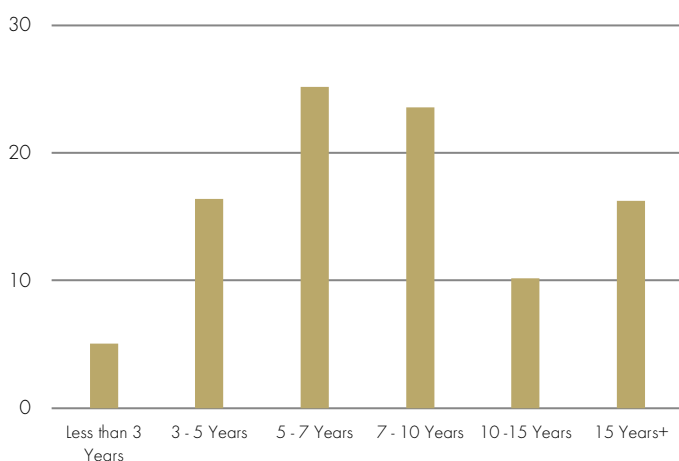

*The Ongoing Charges Figure (OCF) covers all aspects of operating a fund during the course of its financial year. RISK AND REWARD PROFILE



- The Fund is categorised 2 primarily for its exposure to a diversified portfolio of bonds along with a number of derivative positions.
