### What is this product?

**Type** A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

**Term** Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

**Objectives** To provide total returns comprised of capital growth (i.e. to grow the value of your investment) and income over the long term.

**Investment policy** Invests around the world in a range of assets including: equities; bonds; commodities, property, alternative assets, derivatives, transferable securities and other funds. The Fund may hold cash. Bonds may be issued by governments, institutions or companies, including from emerging and frontier markets. May invest in mainland China without limitation, including bonds traded on the China Interbank Bond Market and companies traded on Stock Connect. The Investment Manager may at times utilise global equities (proxied by the MSCI All Country World Total Return Net Index), global government bonds (proxied by the FTSE World Government Bond Index), or a combination of both, as a comparator to measure the risk, return or yield characteristics of the Fund.

**Strategy** Uses a flexible approach to asset allocation, using a broad range of asset classes and investment techniques which allows the Investment Manager to respond effectively to market conditions and investment opportunities. Investment opportunities are identified using macroeconomic analysis and research.

**Sustainability approach – Article 8 SFDR** The Fund promotes environmental and social characteristics in line with Article 8 of the EU Sustainable Finance Disclosure Regulation (SFDR) by making investments in companies and countries that meet the standards of the Investment Manager's proprietary sustainability framework and by excluding investments in certain business groups and activities.

**Derivatives and techniques** Derivatives may be used to achieve the Fund's investment objectives, to manage the Fund's risks or reduce the costs of managing the Fund. The Investment Manager uses a currency hedging strategy that aims to align returns in this currency share class with those achieved in the currency that the Fund's investments are valued in.

**Benchmark(s)** The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives.

**Practical details** The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is reflected in the value of your shares. #### Glossary of terms

**Alternative assets** Non-traditional financial instruments, providing exposure to non-mainstream asset classes such as commodities, property, private equity, private credit and infrastructure.

**Bonds** Tradable contracts issued by governments or companies to repay borrowed money and typically pay interest at fixed periods.

**Derivatives** Financial contracts whose value is linked to the price of an underlying asset.

**Equities** An equity investment is investing in shares in a company, providing an investor with part ownership.

**SFDR** The Sustainable Finance Disclosure Regulation seeks to strengthen and standardise disclosures on the Environmental, Social and Governance ('ESG') characteristics of EU financial products.

**Stock Connect** A share trading link between the Hong Kong Stock Exchange and mainland Chinese equity markets.

**Transferable securities** Financial instruments, such as shares or bonds, which are tradable on capital markets.

## Intended retail investor:

The Fund has been designed to form part of a broader portfolio of investments, but may also be suitable as a significant component of an investor's overall portfolio and can be purchased with advice or on an execution only basis by a basic investor. This share class of the Fund is only available to an investor that qualifies as an 'institutional investor' under Luxembourg administrative practice and can be purchased with advice, on an execution only basis or when providing portfolio management services. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.

## What are the costs?

### Costs over time

If you sell before the end of the recommended holding period, this will increase the risk of lower investment returns or a loss.
