## What is this product?

**Type** A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

**Term** Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

**Objectives** To provide a high level of income with the opportunity to grow the value of your investment over the long term.

**Investment policy** Invests primarily in a range of bonds issued by Latin American governments, institutions or companies, in or with material links to the Latin American region. The Fund's investments may be issued in Latin American local currencies as well as globally traded major currencies. The Fund may invest in other assets and may hold cash.

Sustainability approach – Article 8 SFDR The Fund promotes environmental and social characteristics in line with Article 8 of the EU Sustainable Finance Disclosure Regulation (SFDR) by making investments in borrowers that meet the standards of the Investment Manager's proprietary sustainability framework and by excluding investments in certain borrowers.

**Benchmark(s)** The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives. The JPMorgan CEMBI Broad Diversified Latin America Index is used for performance comparison. The Fund does not seek to replicate the index. It will generally hold assets that are components of the index, but not in the same proportions, and it is allowed to hold assets which are not components of the index. The assets of the Fund therefore may be very different from the index. **Practical details** The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is reflected in the value of your shares. GSF's Depositary is State Street Bank International GmbH, Luxembourg Branch. #### Glossary of terms

**Bonds** Tradable contracts issued by governments or companies to repay borrowed money and typically pay interest at fixed periods. **Derivatives** Financial contracts whose value is linked to the price of an underlying asset.

## Intended retail investor:

The Fund has been designed to form part of a broader portfolio of investments and can be purchased with advice or on an execution only basis by a basic investor. This share class of the Fund is only available to an investor that qualifies as an 'institutional investor' under Luxembourg administrative practice and can be purchased with advice, on an execution only basis or when providing portfolio management services. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.

## What are the risks and what could I get in return?

#### **Risk indicator**



The risk indicator assumes you keep this product for at least 5 years. The actual risk can vary significantly if you sell at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 3 out of 7, which is a mediumlow risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to reduce the value of your investment.

#### Be aware of currency risk. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

## What happens if Ninety One Luxembourg S.A. is unable to pay out?

## What are the costs?

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold your investment and how the fund performs. If you sell before the end of the recommended holding period, this will increase the risk of lower investment returns or a loss.
