Objectives and Investment Policy

Objectives

The investment objective of the Sanlam World Equity Fund (the Fund) is to increase the value of your shares over the long term.

Investment policy

This is a multi-manager Fund that follows a fundamental research driven investment process. The Fund is actively managed and invests in equity securities primarily listed in countries within the MSCI World Index (in US Dollars) (the "Benchmark") but excluding companies which are listed or traded in South Africa.

A maximum of 20% of the Fund may be invested in emerging markets.

The Fund aims to achieve a return exceeding that of the Benchmark of over 200 basis points (before management fees) on a rolling annualised 3 year basis with an ex ante annualised tracking error of up to 10%. There is no guarantee the Fund will achieve the target return and a capital loss may occur.

The Fund may also invest in collective investment schemes (CIS) and exchange traded funds (ETF) which invest in companies as described above.

Why is this Fund in category 6?

The Fund is rated 6 due to its exposure to shares and stocks, and the nature of its investments which include the risks listed below. These factors may impact the value of the Fund's investments or expose the Fund to losses.

Investing in international companies means that currency exchange rate fluctuations will have an impact on the Fund.

The price of shares and the income from them may fall as well as rise and investors may not get back the amount they have invested. The Fund may invest in companies based in emerging markets which may involve additional risks not typically associated with other more established markets such as increased risk of social, economic and political uncertainty.

Investing in a CIS or ETF may lead to payment by the Fund of additional fees and expenses in relation to those CIS or ETF. It may be difficult for the Fund in extreme market conditions to redeem its shares from a CIS or ETF at short notice without suffering a loss. The ability to trade REITS may be more limited than other stocks.
