What is this product?

Type A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

Term Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

Objectives To provide total returns comprised of capital growth (i.e. to grow the value of your investment) and income over the long term.

Investment policy Invests around the world in a range of assets including: equities; bonds; commodities, property, alternative assets, derivatives, transferable securities and other funds. The Fund's aggregate exposure to alternative assets (including property, infrastructure, private equity and commodities) shall not represent more than 30% of the assets of the Fund. Investment in mortgage-backed securities and asset-backed securities combined will not exceed 20% of the assets of the Fund. Investment in Contingent Convertible securities (CoCos) will not exceed 10% of the assets of the Fund. The Fund may hold cash. Bonds may be issued by governments, institutions or companies, including from emerging and frontier markets. May invest in mainland China without limitation, including bonds traded on the China Interbank Bond Market and companies traded on Stock Connect.

Strategy Uses a flexible approach to asset allocation, using a broad range of asset classes and investment techniques which allows the Investment Manager to respond effectively to market conditions and investment opportunities. Investment opportunities are identified using macroeconomic analysis and research.

Sustainability approach – Article 8 SFDR The Fund promotes environmental and social characteristics in line with Article 8 of the EU Sustainable Finance Disclosure Regulation (SFDR) by making investments in companies and countries that meet the standards of the Investment Manager's proprietary sustainability framework and by excluding investments in certain business groups and activities.

Derivatives and techniques Derivatives may be used to achieve the Fund's investment objectives, to manage the Fund's risks or reduce the costs of managing the Fund.

Benchmark(s) The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives.

Practical details The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is reflected in the value of your shares. Glossary of terms

Alternative assets Non-traditional financial instruments, providing exposure to non-mainstream asset classes such as commodities, property, private equity, private credit and infrastructure.

Asset-backed securities Financial products that package pools of income producing assets, such as auto loans, student loans, or credit card debt, into tradable securities.

Bonds Tradable contracts issued by governments or companies to repay borrowed money and typically pay interest at fixed periods.

Contingent Convertible securities (CoCos) Bonds that convert into shares if a pre-defined trigger event occurs.

Derivatives Financial contracts whose value is linked to the price of an underlying asset.

Equities An equity investment is investing in shares in a company, providing an investor with part ownership.

Mortgage-backed securities Financial products that package pools of residential or commercial mortgages into tradable securities.

SFDR The Sustainable Finance Disclosure Regulation seeks to strengthen and standardise disclosures on the Environmental, Social and Governance ('ESG') characteristics of EU financial products.

Stock Connect A share trading link between the Hong Kong Stock Exchange and mainland Chinese equity markets.

Transferable securities Financial instruments, such as shares or bonds, which are tradable on capital markets.

Intended retail investor:

This Fund has been designed to form part of a broader portfolio of investments, but may also be suitable as a significant component of an investor's overall portfolio and should be purchased with advice or on an execution only basis by a basic investor. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.
