What is this product?

Type:

- This product is a UCITS Fund.
- The Company has appointed The Bank of New York Mellon SA/NV, Dublin Branch, to act as the depositary of the Company's assets pursuant to the Depositary Agreement

Term:

- This investment has no fixed maturity date.
- The Fund may be terminated at any time in line with the constitutional documents of the plc.

Objectives

The Fund aims to achieve long term capital growth by investing primarily in European smaller companies. The Fund's investment objective is to target capital growth for investors. Growth stocks tend to pay out lower levels of dividend resulting in lower income yields and may produce more volatile returns than the market as a whole. The Fund invests globally, although it is intended to invest primarily in Developed European equities. The Fund invests in smaller companies (with a market cap of <€5 billion at the time of initial investment). The Fund may also invest in other eligible asset classes as detailed within the prospectus. The Fund may, under certain circumstances, invest in derivatives but it is not intended that their use will materially affect volatility. Derivatives are used to protect against currencies, credit and interest rate moves or for investment purposes. The use of derivatives may create leverage or gearing resulting in potentially greater volatility or fluctuations in the net asset value of the Fund. - The fund managers focus on the historic cash flows generated and invested by companies to support their forecast profits growth. As forecasts are often unreliable, the scale of cash invested to support forecasts is key. The fund managers seek to own companies that generate significantly more cash than they need to sustain their planned growth yet are lowly valued by investors on that measure and are run by managers committed to an intelligent use of capital. To identify companies' annual cash flow, balance sheet development and valuation efficiently across all equity markets the fund managers have developed a simple screen as a starting point for further qualitative analysis. The investment screen consists of two cash flow ratios that are combined equally to highlight the process characteristics that they seek. The two cash flow measures are: Cash flow relative to operating assets, Cash flow relative to market value.
- Dealing Frequency: Shares in the Fund can be bought and sold, either in whole or in part, every business day. An application must be submitted to the administrator, BNY Mellon Fund Services (Ireland) LIMITED, by 11:59 am on the business day of the purchase or sale.  The Fund is considered to be suitable for investors seeking long-term capital growth over a medium to long term investment horizon (at least 5 years) and who understand and are prepared to accept the risks and a medium to medium/high level of volatility, particularly given the Fund's equity investment.

Risk Indicator
