The Fund seeks to achieve capital growth and income with a low level of volatility. The underlying funds in the portfolio invest globally, including in emerging markets, across asset classes and financial instruments and will, where practicably possible, be passive. The Fund typically has a lower exposure to higher risk assets and a greater exposure to lower risk assets than other funds in the Liontrust MA Dynamic Passive Funds range that have a higher risk profile.

There is currently no charge for switching funds, however the number of switches is limited to a max of one per calendar month.

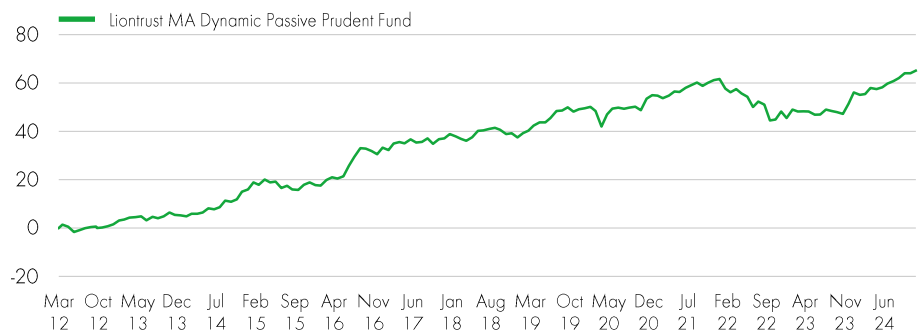

## PERFORMANCE SINCE CLASS LAUNCH DATE (%)



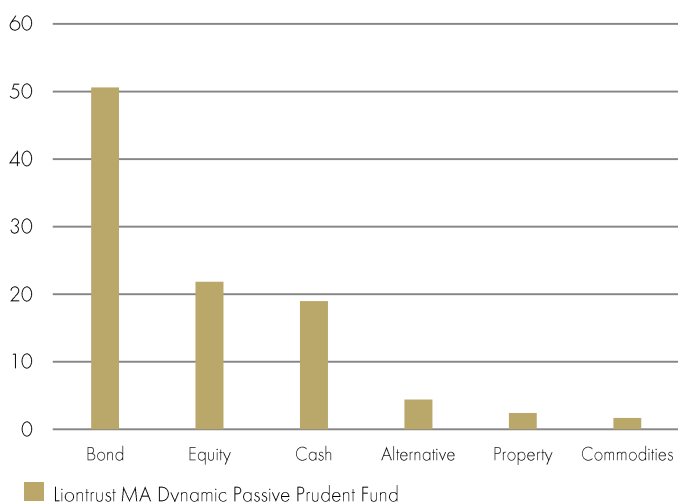
