## THE FUND

The Fund seeks to achieve capital growth and income with a below median level of volatility. The Fund invests in fixed income, UK and equities globally, including a small exposure to emerging markets, and UK property. The underlying funds will, where practicably possible, be passive. The Fund typically has a lower exposure to higher risk assets and a greater exposure to lower risk assets compared to other funds in the Liontrust MA Dynamic Passive Funds range that have a higher risk profile.

## INVESTOR NOTIFICATION

There are two ways in which Liontrust and other asset managers show the costs of funds: the UCITS Ongoing Costs Figure and the MiFID Ongoing Cost. There is currently no charge for switching funds, however the number of switches is limited to a max of one per calendar month.

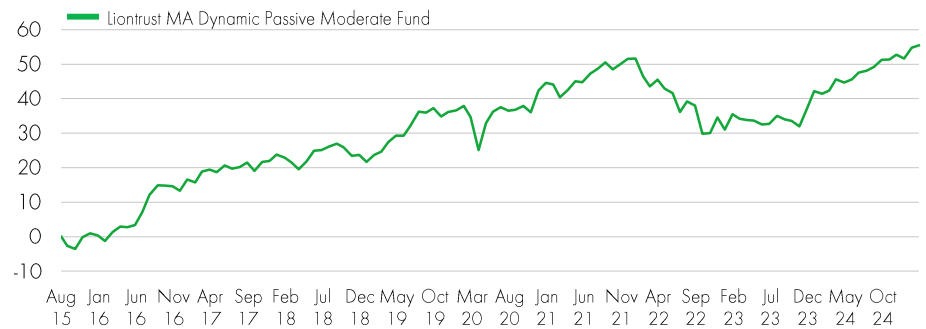

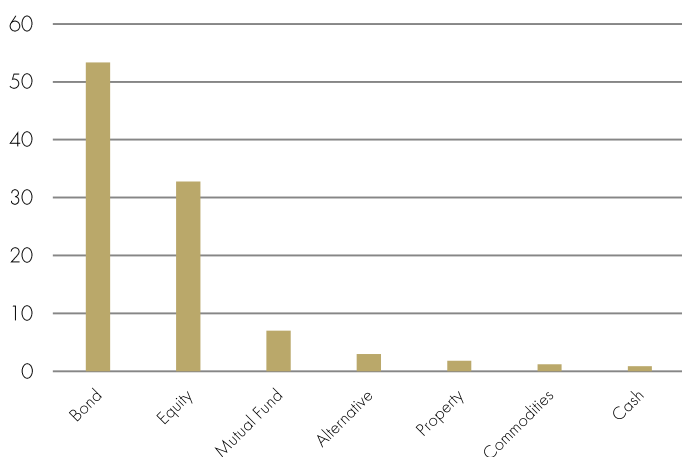
