The Fund typically has a balanced exposure to higher risk assets and lower risk assets compared to other funds in the Liontrust MA Dynamic Passive Funds range that have a higher or lower risk profile.

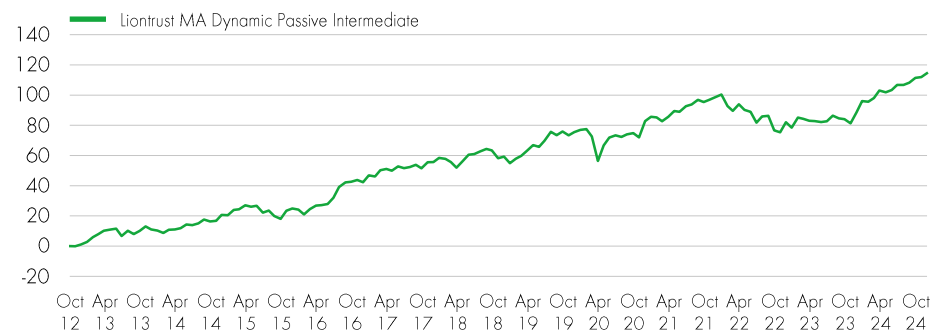

## PERFORMANCE SINCE CLASS LAUNCH DATE (%)



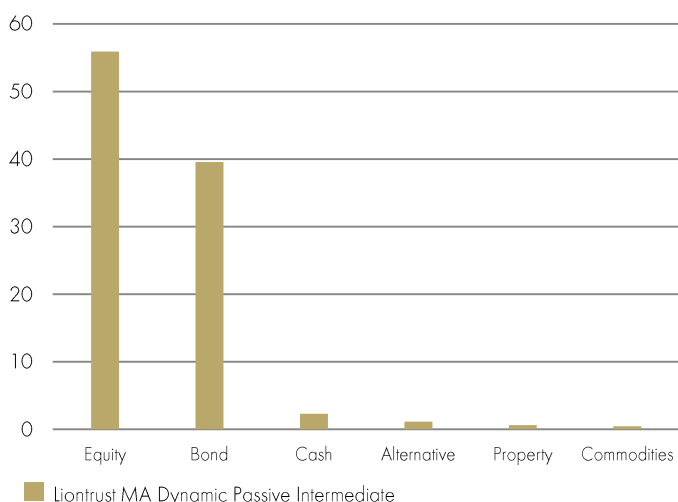
