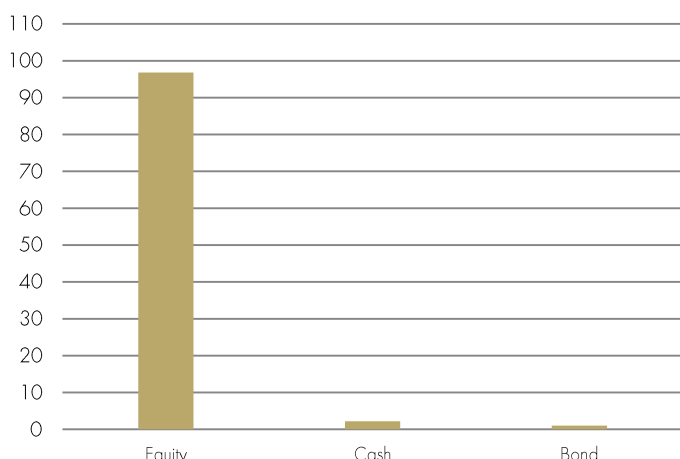

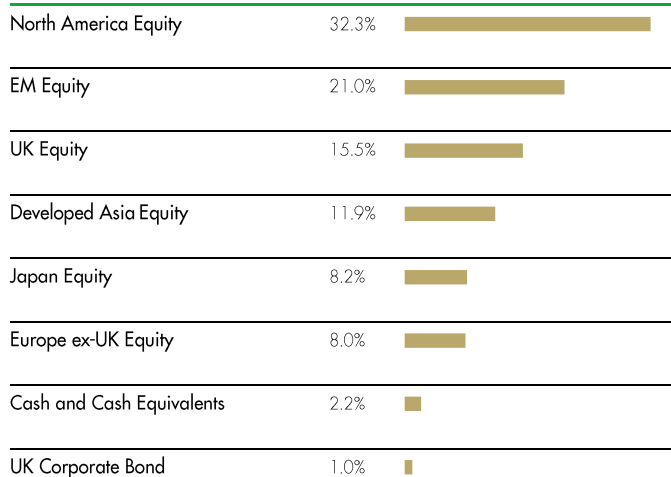


## ASSET ALLOCATION VS SAA (%)
