THE PORTFOLIO

The portfolio aims to grow capital in line with the rate of inflation (CPI) over the long term (more than five years) with a low level of volatility. Around half the portfolio invests in cash and money market funds, with the rest investing in fixed income and equities with a potentially small allocation to alternatives. The majority of the equity allocation invests in developed markets.

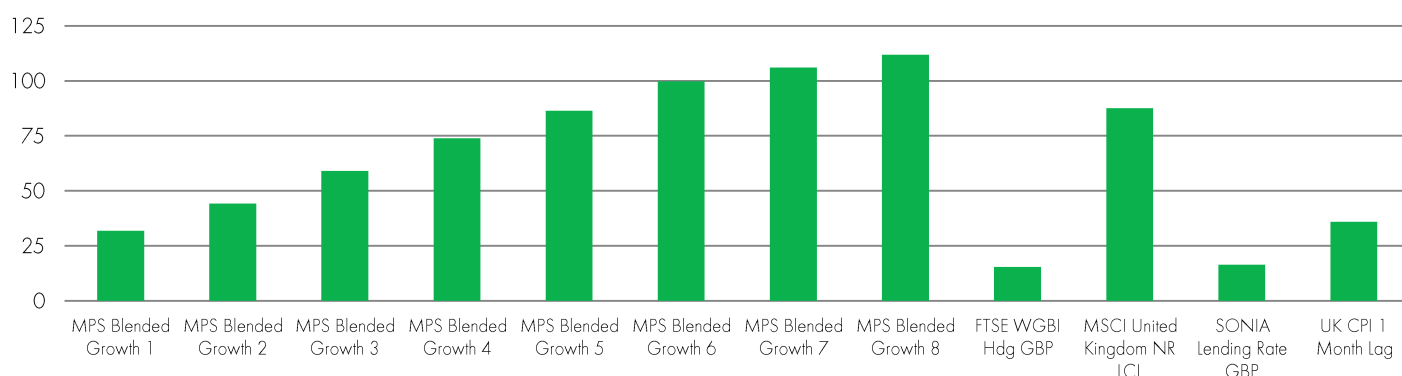

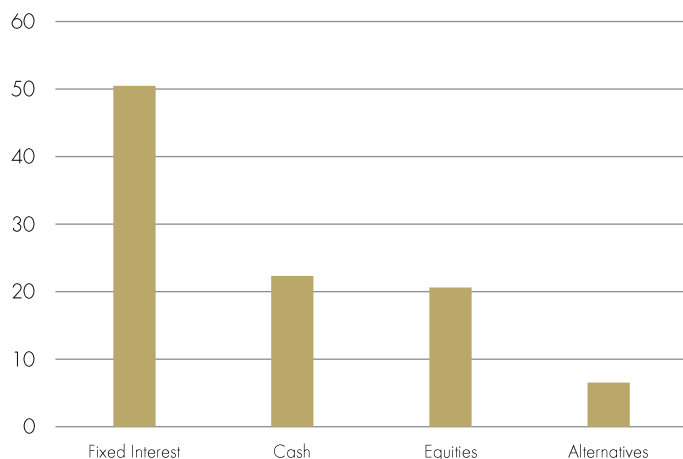
PERFORMANCE SINCE LAUNCH (%)
