The Fund typically has greater exposure to higher risk assets than other funds in the Liontrust MA Dynamic Passive Funds range that have a lower risk profile.

PERFORMANCE SINCE CLASS LAUNCH DATE (%)



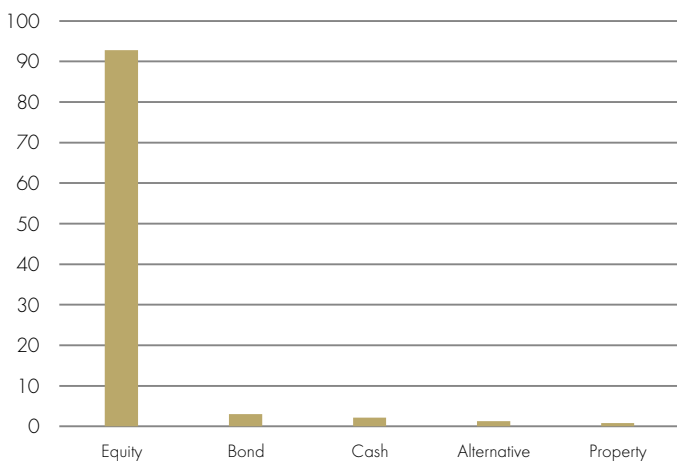
