# What is this product?

**Type** A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

**Term** Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

**Objectives** To achieve total returns comprised of capital growth (i.e. to grow the value of your investment) and income over the long term. Aims to make sustainable investments that contribute to the environmental objective of climate change mitigation. It does this by investing in companies which are believed to contribute to positive environmental change through sustainable decarbonisation.

**Investment policy** Invests primarily in the shares of companies around the world and in related securities. The Fund may invest in other assets and may hold cash.

Sustainability approach – Article 9 SFDR This Fund is classified under Article 9 of the EU Sustainable Finance Disclosure Regulation. Article 9 applies to products which, alongside their financial investment objectives, have specific investment objectives to invest sustainably. Invests in companies that generate the majority of their revenues from environmental activities that contribute to decarbonisation. These companies are typically committed to renewable energy, electrification and resource efficiency. The Fund will not knowingly invest in companies which derive more than 5% of their revenues from coal, oil and gas exploration and production.

**Derivatives and techniques** Derivatives may be used to manage the Fund's risks or reduce the costs of managing the Fund.

Benchmark(s) The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives. The MSCI AC World Net Return Index is used for performance comparison. The Fund does not seek to replicate the index. It will generally hold assets that are components of the index, but not in the same proportions, and it is allowed to hold assets which are not components of the index. The assets of the Fund therefore may be very different from the index.

Practical details The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is paid out to you. GSF's Depositary is State Street Bank International GmbH, Luxembourg Branch. The assets and liabilities of the Fund are segregated under Luxembourg law and an investment in the Fund cannot be used to meet the debts or, claim against, any other person, including any other GSF sub-fund. You may switch between GSF funds or share classes of the same fund; details are in the 'Conversion of Shares' section of the prospectus. #### Glossary of terms

**Decarbonisation** The process of reducing greenhouse gas emissions. **Derivatives** Financial contracts whose value is linked to the price of an underlying asset.

**Securities** A general term for tradable financial instruments or assets, such as shares or bonds.

**Sustainability** Seeking to prevent the depletion of natural or physical resources, so that they will remain available for the long term.

## Intended retail investor:

This Fund has been designed to form part of a broader portfolio of investments and should be purchased with advice or on an execution only basis by a basic investor. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.

# What are the risks and what could I get in return?

#### Risk indicator
