THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years) with a high level of volatility. Close to all of the portfolio invests in equities, of which a small majority may be in Asia and emerging markets and around a quarter in smaller companies listed in developed markets. 5% or less in total of the portfolio may invest in alternative investment funds, commodities, cash/money market funds and fixed income. The portfolio predominantly, although not exclusively, uses passive strategies.

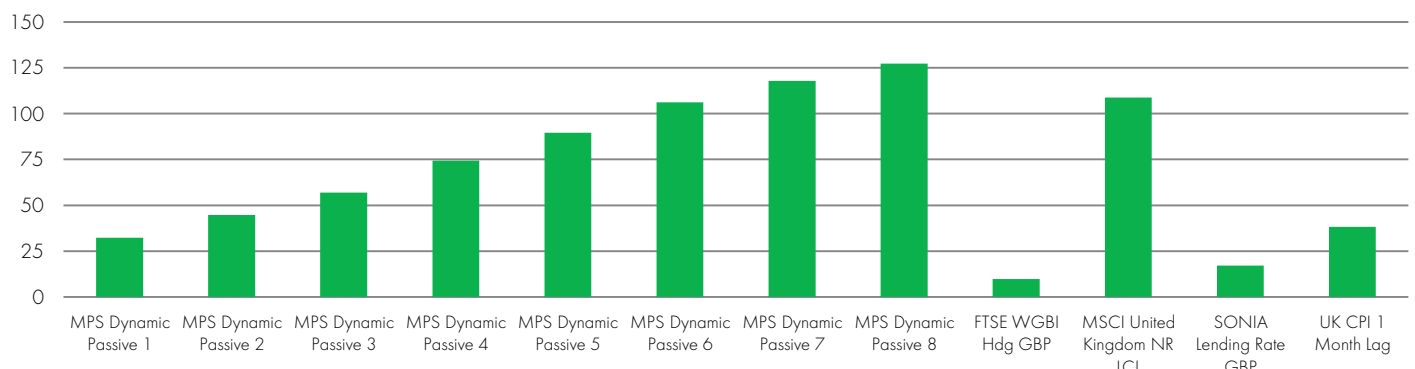

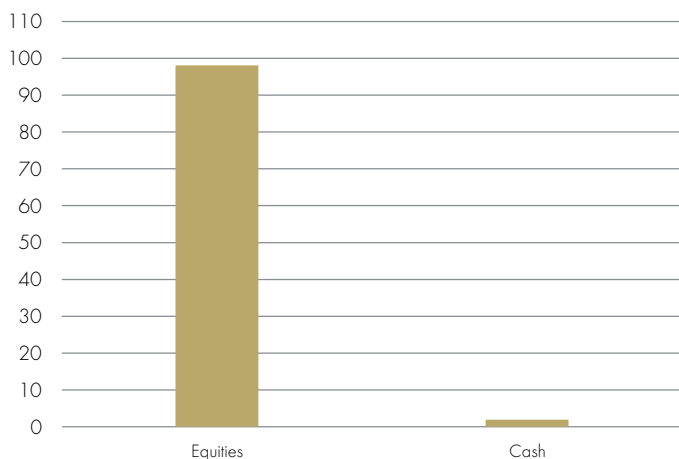
PERFORMANCE SINCE LAUNCH (%)
