THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years) with a high level of volatility. Most (typically around 90%) of the portfolio invests in equities, the majority in developed markets and around 40% in Asia and emerging markets, 5% or less of the portfolio invests in alternatives, commodities, cash/money market funds and fixed income. The portfolio predominantly, although not exclusively, uses passive strategies.

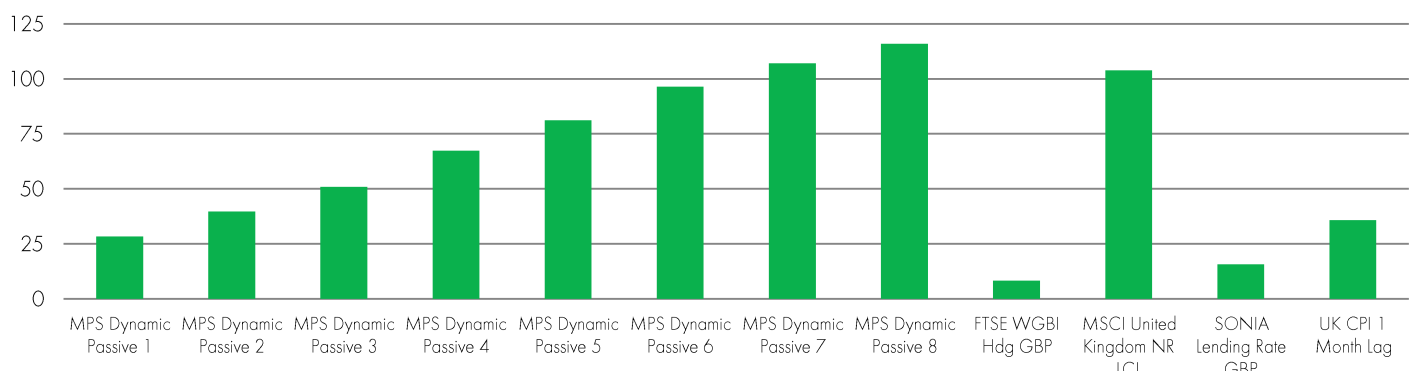

PERFORMANCE SINCE LAUNCH (%)

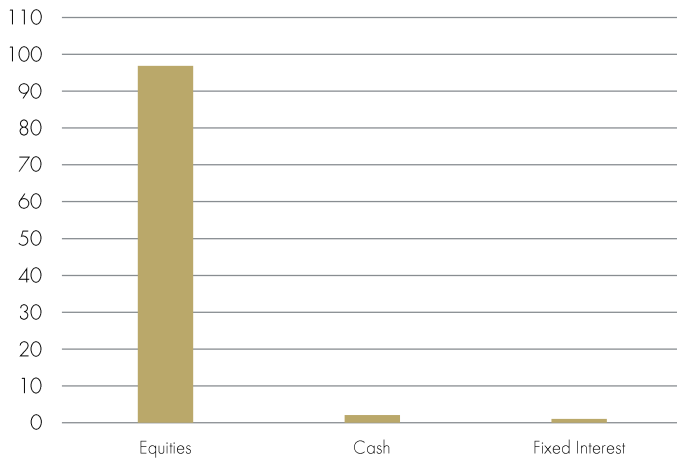
