## What is this product?

**Type** A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

**Term** Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

**Objectives** To provide income with the opportunity to grow the value of your investment over the long term.

Investment policy Seeks to limit volatility to be lower than 50% of the volatility of global equities. There is no guarantee that this will be achieved over the long-term or any period of time. Invests globally in a range of assets including: bonds, the shares of companies, alternative assets, derivatives, transferable securities and in other funds. The Fund may hold cash. Normally, exposure to shares of companies will be no more than 40% of the value of the Fund. Bonds may be issued by governments, institutions or companies, including from emerging and frontier markets. May invest up to 25% of its value in emerging and frontier markets and up to 20% of its value in mainland China, including bonds traded on the China Interbank Bond Market and companies traded on Stock Connect. The Investment Manager may at times utilise global equities (proxied by the MSCI All Country World Total Return Net Index) and bonds (proxied by the Bloomberg Barclays Global-Aggregate Total Return Index or representative components) to measure the risk and return characteristics of the Fund.

**Strategy** Focuses on investing in assets expected to provide a reliable level of income and opportunities for capital growth in many market conditions. Investment opportunities are identified using in-depth analysis and research on individual companies and countries.

Sustainability approach – Article 8 SFDR The Fund promotes environmental and social characteristics in line with Article 8 of the EU Sustainable Finance Disclosure Regulation (SFDR) by making investments in companies and countries that meet the standards of the Investment Manager's proprietary sustainability framework and by excluding investments in certain business groups and activities.

Derivatives and techniques Derivatives may be used to achieve the Fund's investment objectives, to manage the Fund's risks or reduce the costs of managing the Fund. The Investment Manager uses a currency hedging strategy that aims to align returns in this currency share class with those achieved in the currency that the Fund's investments are valued in. In addition, this hedging strategy seeks to generate additional distributions from currency movements.

**Benchmark(s)** The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives.

**Practical details** The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is paid out to you. This share class gives priority to income, rather than to capital growth, and will typically distribute more than the income received by the Fund. Inclusion of any interest rate differential between the currencies resulting from the hedging strategy will be considered a distribution from capital or capital gains. This may be tax inefficient for investors in certain countries. #### Glossary of terms

Alternative assets Non-traditional financial instruments, providing exposure to non-mainstream asset classes such as commodities, property, private equity, private credit and infrastructure.

**Bonds** Tradable contracts issued by governments or companies to repay borrowed money and typically pay interest at fixed periods.

**Derivatives** Financial contracts whose value is linked to the price of an underlying asset.

**SFDR** The Sustainable Finance Disclosure Regulation seeks to strengthen and standardise disclosures on the Environmental, Social and Governance ('ESG') characteristics of EU financial products.

Transferable securities Financial instruments, such as shares or bonds, which are tradable on capital markets.

**Volatility** A measure of the size of short term changes in the value of an investment.

### Intended retail investor:

This Fund has been designed to form part of a broader portfolio of investments, but may also be suitable as a significant component of an investors overall portfolio and should be purchased with advice or on an execution only basis by a basic investor. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.

## What are the risks and what could I get in return?

#### **Risk indicator**



The risk indicator assumes you keep this product for at least 5 years. The actual risk can vary significantly if you sell at an early stage and you may get back less.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to reduce the value of your investment.

## What are the costs?

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs.
