### THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years) with a medium level of volatility. Most (typically around 80%) of the portfolio invests in equity funds, the majority of which is in developed markets and around a quarter in Asia and emerging markets. Around a fifth of the portfolio is in alternatives, fixed income and cash/money market funds. The portfolio predominantly, although not exclusively, uses passive strategies.




### PERFORMANCE SINCE LAUNCH (%)
