THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years), with a medium level of volatility. Most (typically around two-thirds) of the portfolio invests in equities. The majority of this equity allocation is in developed markets and there may also be an exposure to Asia and emerging markets. Around a third of the portfolio invests across alternatives, fixed income and cash/money market funds. The portfolio predominantly, although not exclusively, uses passive strategies.

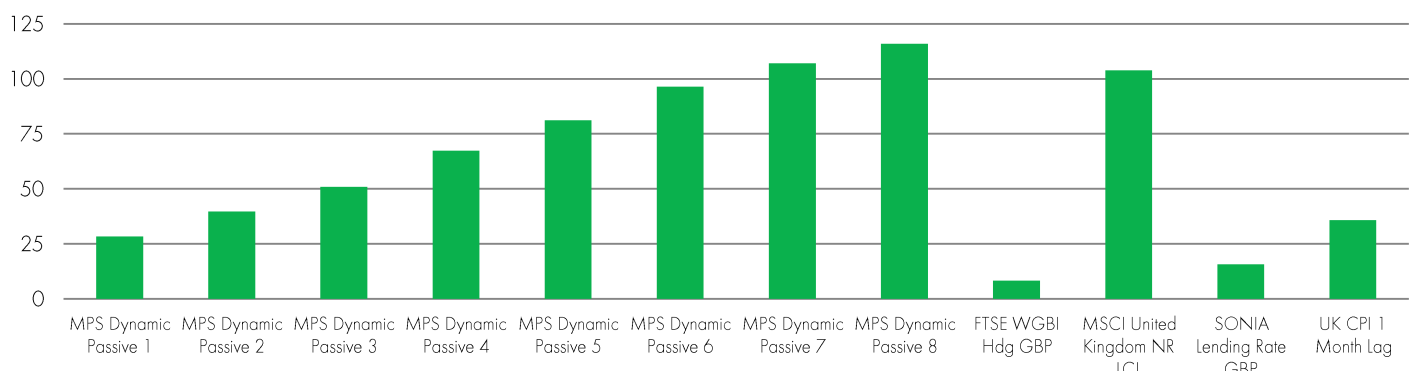

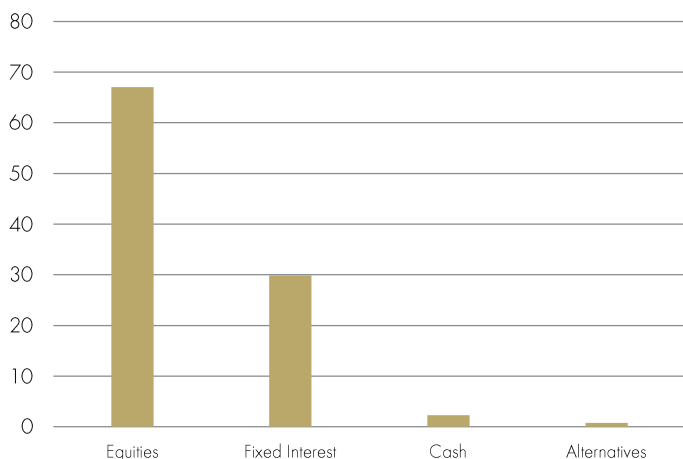
