THE PORTFOLIO

The portfolio aims to grow capital at least in line with the rate of inflation (CPI) over the long term (more than five years) with a low level of volatility. Around a quarter of the portfolio invests in in cash and money market funds, a third in bonds and the remainder largely in equities. The majority of the equity allocation invests in developed markets and there may be a small holding in alternatives. The portfolio predominantly, although not exclusively, uses passive strategies.




PERFORMANCE SINCE LAUNCH (%)


ASSET ALLOCATION WEIGHTINGS (%)
