THE PORTFOLIO

The portfolio aims to provide an income while looking to grow capital at least in line with the rate of inflation (CPI) over the long term (more than five years) with a low level of volatility. Around a quarter of the portfolio invests in cash and money market funds, a third in bonds and the remainder largely in equities. The majority of the equity allocation invests in developed markets. The portfolio may have a small holding in alternatives.

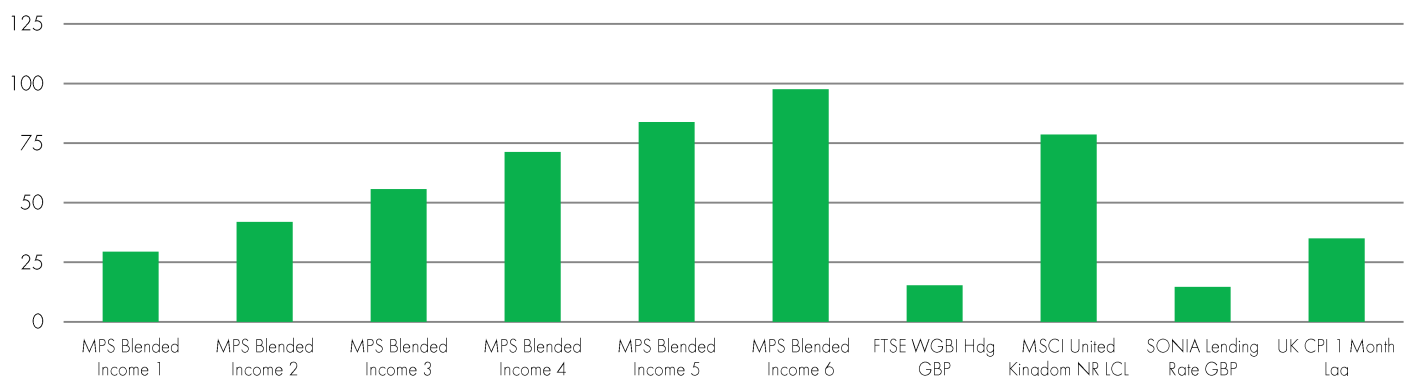

PERFORMANCE SINCE LAUNCH (%)

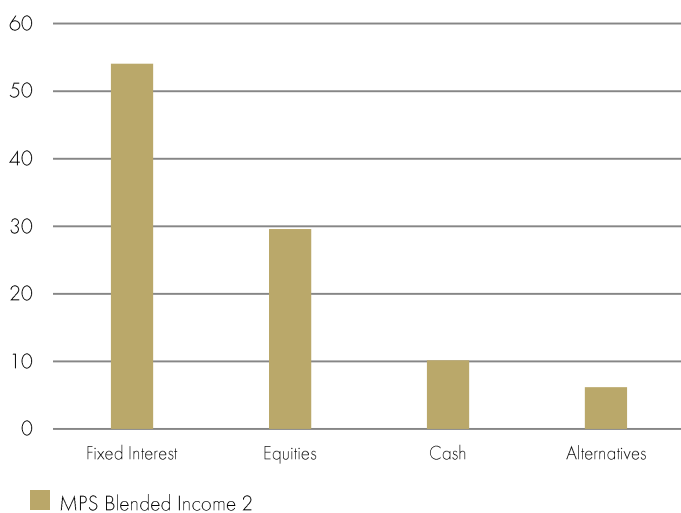
