## Objectives and Investment Policy

### Investment Objective

The investment objective of the Sanlam Active UK Fund (the “Fund”) is to increase the value of your shares over the longer term.

### Investment Policy

The Fund is actively managed and shall invest in stocks and shares of companies listed on stock exchanges in the UK and in instruments which have the same or a similar effect as investing in stocks and shares of such companies.

The Fund may also invest in companies listed on non-UK markets to the value of 20% of the Net Asset Value of the Fund,

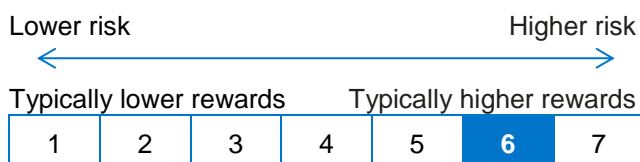
You can sell your shares in the Fund any day (except Saturday or Sunday) that banks are open in Ireland and the UK.

The Fund may measure its performance relative to a benchmark index (MSCI UK Index GBP) for reference or investor communication purposes, including in the Company's annual and half-yearly reports. However the performance of the Fund relative to the benchmark index is not factored in any way into the investment process and the Fund does not operate any form of target to outperform the benchmark index.

Your shares may pay you income, any income you may be entitled to will be paid in or around 28 February of each year.

Recommendation: The Fund is suitable for investors with a time horizon of 5 years.

## Risk and Reward Profile



### Why is this Fund in category 6?

The Fund is rated 6 due to the nature of its investments which include the risks listed below.

These factors may impact the value of the Fund's investments or expose the Fund to losses.

The price of shares and the income from them may fall as well as rise and you may not get back the amount you have invested.

### What do these numbers mean?

They rate how a fund might behave and how much risk there is to your capital. Generally, the chance to make large gains means a risk of suffering large losses.

A **Category 1** fund is not a risk-free investment - the risk of losing your money is small, but the chance of making gains is also limited. With a **Category 7** fund, the risk of losing your money is high but there is also a chance of making higher gains. The seven-category scale is complex (for example, 2 is not twice as risky as 1).

### More about this rating:

This rating system is based on the average fluctuations of the prices of funds over the past 5 years - that is, by how much the value of their assets taken together has moved up and down. Historical data, such as is used in calculating the synthetic risk indicator, may not be a reliable indication of the future risk profile of the Fund.

## Charges

These charges are used to pay the costs of running the Fund, including the costs of marketing and selling. Overall, they reduce the growth of your investment.

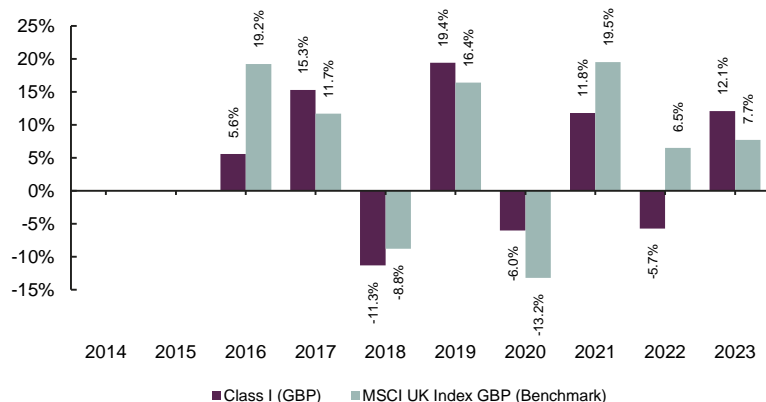
