## THE PORTFOLIO

The portfolio aims to provide an income while looking to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years) with a medium level of volatility. Most (typically around 80%) of the portfolio invests in equities, the majority of which invests in developed markets and around a quarter is in Asia and emerging markets. Around a fifth of the portfolio invests in alternatives, fixed income and cash and money market funds.

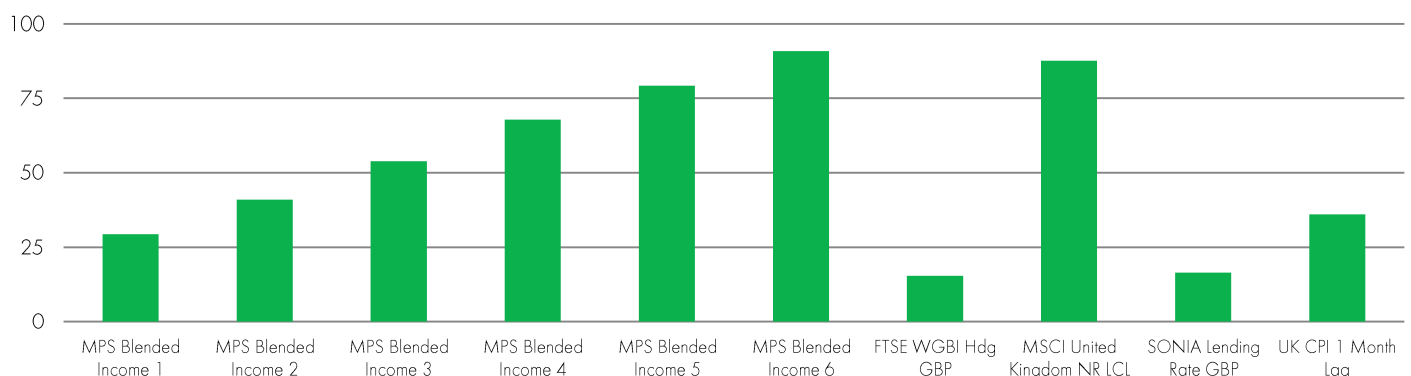

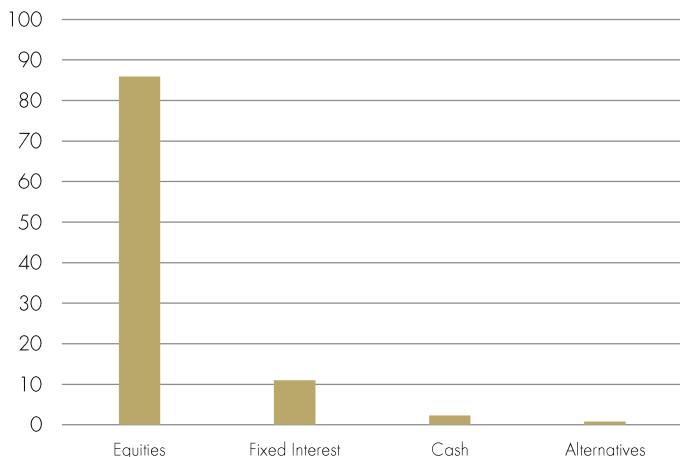
