THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years) with a high level of volatility. Close to all of the portfolio invests in equities, within which the majority (around 90%) may invest in Asia and emerging markets. Around half of the rest of the portfolio invests in smaller companies listed in developed markets. A very small proportion of the portfolio may be allocated to cash and money market funds, alternatives, commodities and fixed income.






ASSET ALLOCATION WEIGHTINGS (%)
