THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years) with a high level of volatility. Close to all of the portfolio invests in equities, the majority (around three-quarters) of which may be invested in Asia and emerging markets. Around half of the rest of the portfolio may be allocated to smaller companies listed in developed markets. 5% or less of the portfolio invests in cash and money market funds, alternatives, commodities and fixed income.

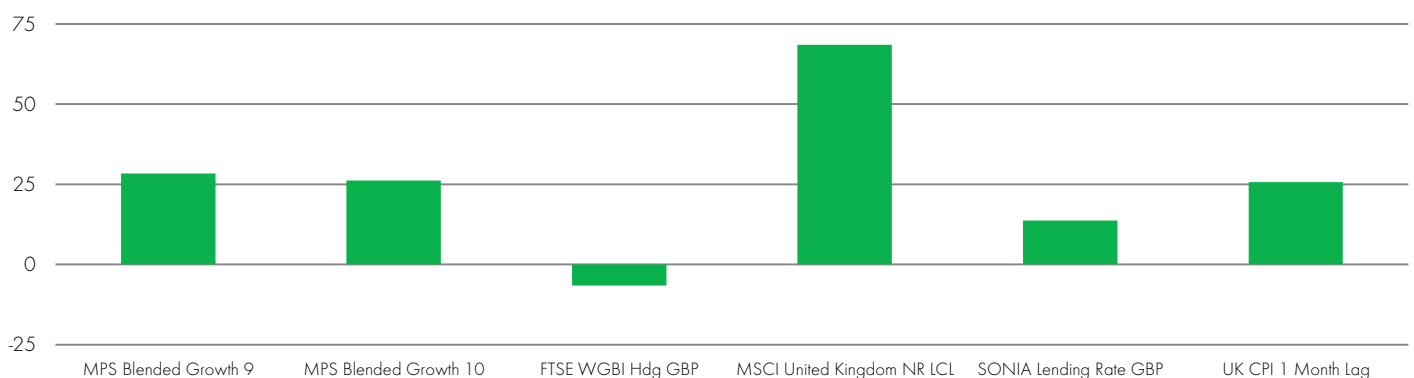

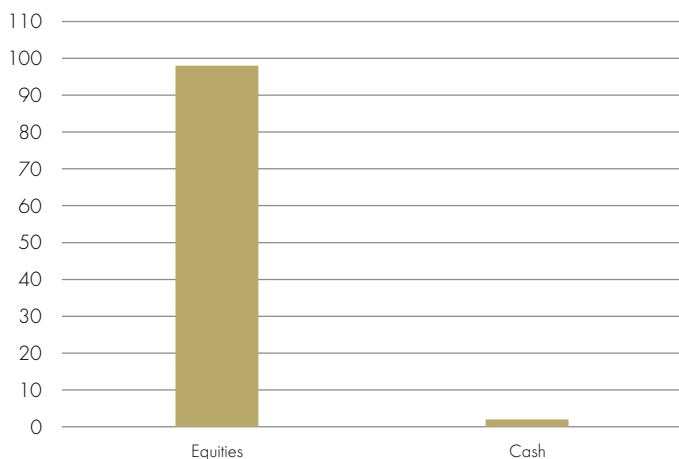
PERFORMANCE SINCE LAUNCH (%)
