What is this product?

Type A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

Term Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

Objectives To grow the value of your investment over the long term.

Investment policy Invests primarily in the shares of companies either in emerging markets or with material links to these markets. May invest up to 20% of its value in mainland China, including companies traded on Stock Connect. The Fund may invest in other assets and may hold cash.

Strategy Invests in shares of high quality, attractively valued companies, with improving operating performance, that are receiving increasing investor attention.

Derivatives and techniques Derivatives may be used to manage the Fund's risks or reduce the costs of managing the Fund.

Benchmark(s) The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives. The MSCI Emerging Markets Net Return Index is used for performance comparison and risk management. The Fund does not seek to replicate the index. It will generally hold assets that are components of the index, but not in the same proportions, and it is allowed to hold assets which are not components of the index. The Fund will therefore generally look different from the index, and the Investment Manager will monitor performance differences.

Practical details The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is reflected in the value of your shares. GSF's Depositary is State Street Bank International GmbH, Luxembourg Branch. Risk indicator
