THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years) with a high level of volatility. Close to all of the portfolio invests in equities, a small majority of which may be invested in Asia and emerging markets and around a quarter in smaller companies listed in developed markets. 5% or less of the portfolio may be invested in alternatives, commodities, cash/money market funds and fixed income.

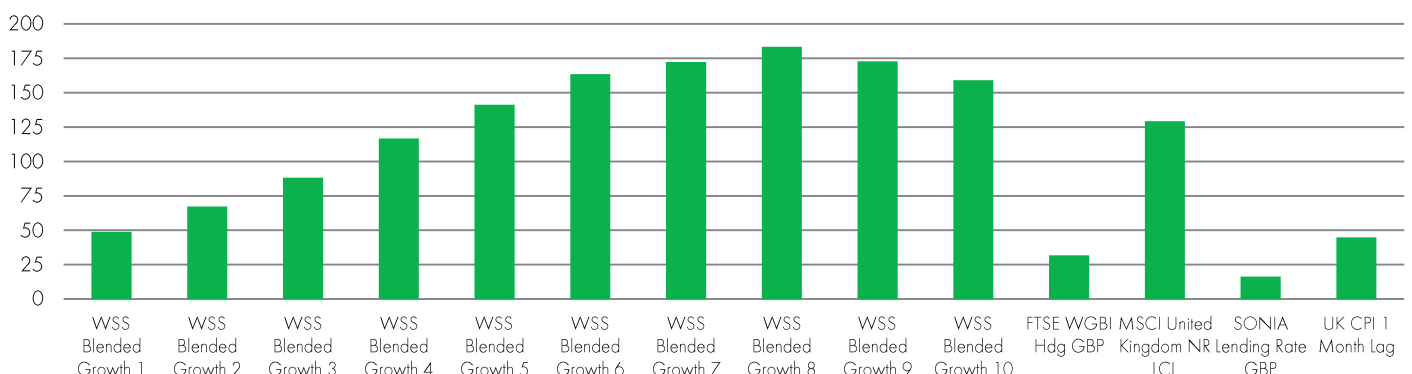

PERFORMANCE SINCE LAUNCH (%)

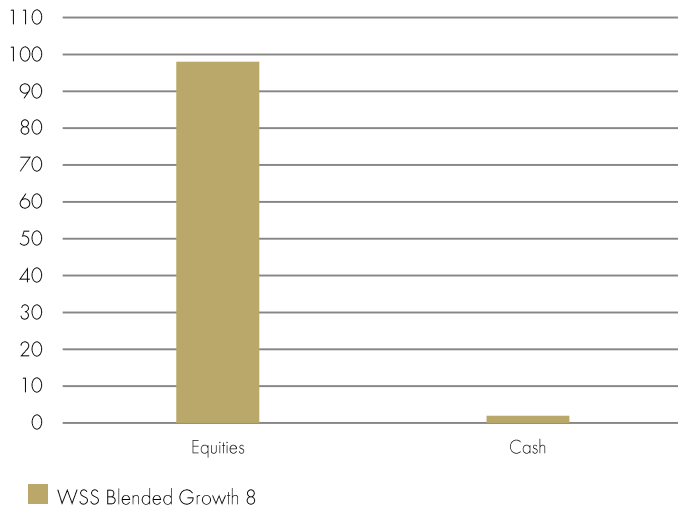

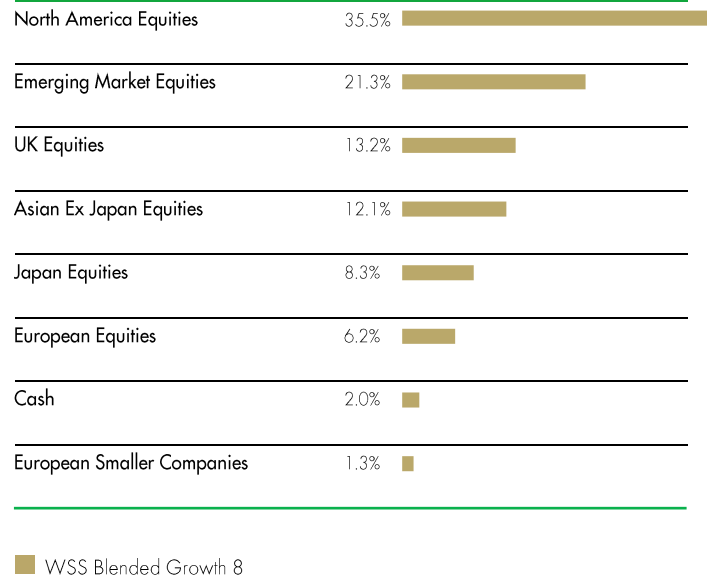
ASSET ALLOCATION WEIGHTINGS (%)
