THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years) with a high level of volatility. Most (typically around 90%) of the portfolio invests in equities, the majority of which is in developed markets and around 40% is allocated to Asia and emerging markets. 5% or less of the portfolio may invest in alternatives, commodities, cash/money market funds and fixed income.

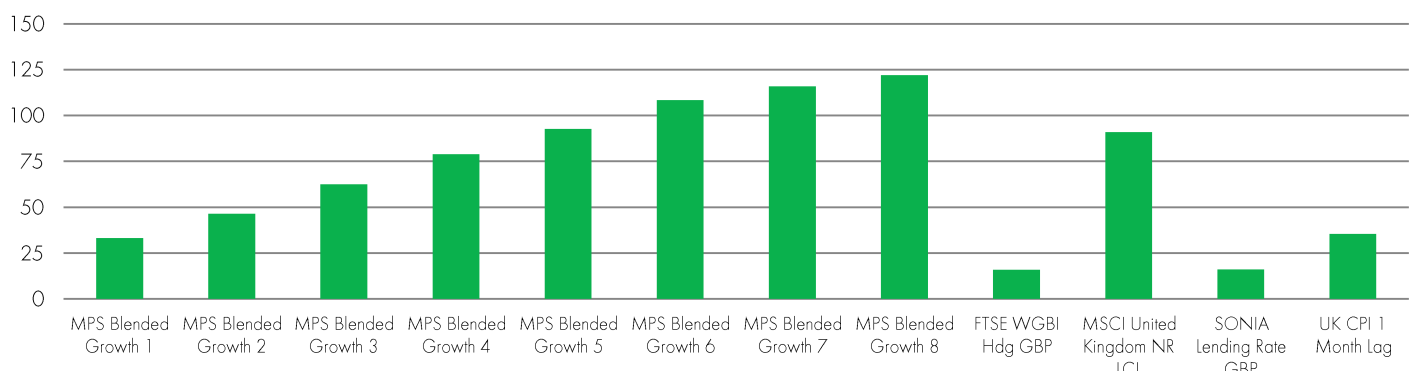

PERFORMANCE SINCE LAUNCH (%)

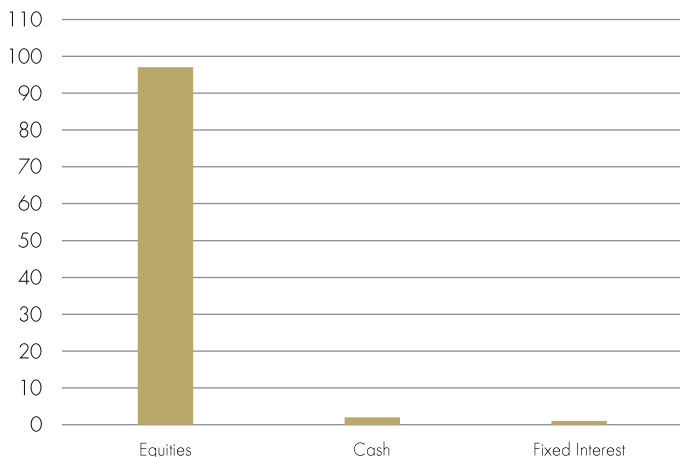

The performance figures shown above are net of the weighted OCF (meaning the cost has been taken off the performance figures) and gross of the DIM fee and any other fees, including any platform and IFA fees that may be applicable (meaning the fees have not been taken off the performance figures and therefore the actual returns achieved will be lower).
