THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years) with a medium level of volatility. Most (typically around 80%) of the portfolio invests in equities, the majority of which is in developed markets and around a quarter is allocated to Asia and emerging markets. Around a fifth of the portfolio invests in alternatives, fixed income and cash/money market funds.

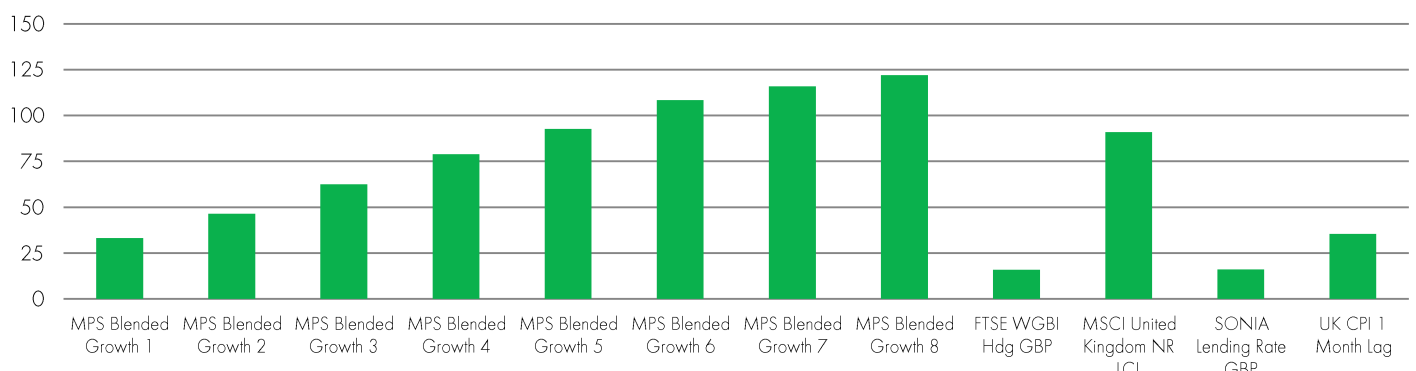

PERFORMANCE SINCE LAUNCH (%)

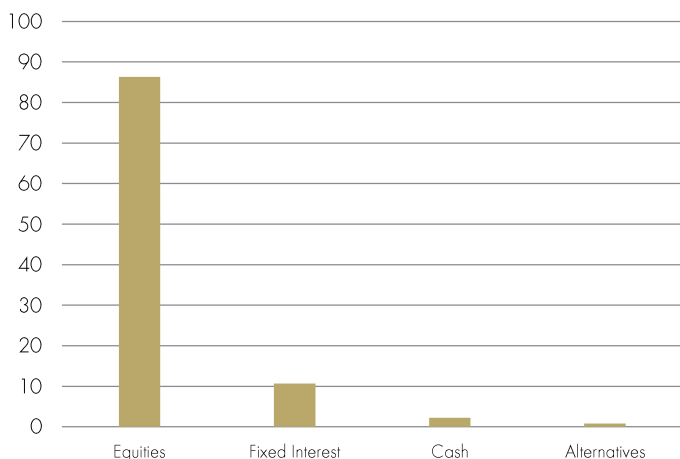

The performance figures shown above are net of the weighted OCF (meaning the cost has been taken off the performance figures) and gross of the DIM fee and any other fees, including any platform and IFA fees that may be applicable (meaning the fees have not been taken off the performance figures and therefore the actual returns achieved will be lower).
